## **Application Process**

#### **Application Review**

- Complete pre-application checklist and book appointment with Housing staff for review
- Complete and submit full application with supporting documents once preapplication checklist is approved by Housing staff

# <u>City staff will facilitate the following process:</u>

- Property pre-inspection and postinspection
- Preparation of Work Description and Bid Proposal forms
- Forgivable Loan Agreement and Construction Contract to Issue Notice to Proceed
- Direct invoice payments to contractor(s)
- All work is inspected and approved prior to payment release.

#### Applicant is responsible for the following:

- Pre-application checklist and application with supporting documents
- Obtain three written contractor estimates (Contractors must be licensed, bonded and insured\*)
- Review of work description, bid proposal, agreement, construction contract, and other documents as applicable, in a timely manner
- Complete cooperation with the contractor, inspectors and City staff.

\*Prior to authorizing any work, the City must pre- approve the contractor

# Emergency Repair Program

## **Program Information**

This program is designed to help eligible owner-occupied homeowners with a forgivable loan to make emergency repairs to single-family homes and eligible mobilehomes within El Cajon city limits (see guidelines for more details). The loan is forgiven one-fifth (1/5) for each year of certified and verified owner-occupancy for a total of five (5) years. Funding is available on a first come, first served basis.



Total Funding: \$10,000

Eligible costs include only emergency repairs such as electrical repairs, replacement of water heaters, leaking or broken windows, roof replacement/repair, plumbing repairs, HVAC replacement, and other eligible emergency repairs that impact the habitability of the unit.

Ineligible costs include interior furnishing, moving expenses, landscaping, luxury Items (e.g. pools and non-standard grade items) and window air conditioning units.

## **Eligibility Requirements**

To qualify for the program. applicants must:

- Be owner-occupant of a single family home or mobile home
- · Live within the El Cajon City limits
- Have a total maximum household income of 50% or below the Area Median Income (AMI). See table below.
- Liquid assets may not exceed \$25,000
- Tenants are NOT eligible to apply for this program.

## **Program Information**

What if I have unpermitted structures? Structures must be permitted or demolished before the City can assist with emergency repairs.

#### Is there application prority?

Yes, priority will be given to the following:

- Applicants who reside in the <u>City's</u>
   <u>Environmental Justice Areas</u>\* or located in a <u>Racially and Ethnically</u>
   <u>Concentrated Areas of Poverty</u>
   (<u>RECAPs</u>)\*;
- Seniors age 62 and over; or
- Applicants with a severally disabled household member\*\*.

### How often can I apply?

Homeowners are eligible to apply once and must not have received a prior City grant.
