CAMACHO summarized the agenda report in a PowerPoint and noted that staff is recommending that the Planning Commission adopt the proposed resolution denying the applicant's appeal of the Director's decision.

Commissioners sought clarification of the Crystal Ballroom application for adult day care. Staff replied that no permits were obtained so the Conditional Use Permit for the use expired.

Mr. Michael TERZIBACHIAN, the applicant, requested additional time. He submitted binders to the Planning Commissioners (reviewed by City Attorney), and addressed existing day care centers in El Cajon and over-concentration concerns. He referred to binder materials which included site plan with allocated parking spaces, and a proposed traffic circulation plan which would also utilize shuttle service to transport patients.

Ms. Lula SHAMOUN, an operator of another adult day care, said that she was opposed and urged Commission not to approve the appeal.

Mr. Lynn McDOUGAL urged that the appeal be approved.

Motion was made by MROZ, seconded by TURCHIN, to close the public hearing; carried 5-0.

Discussion ensued among commissioners over amount of adult care centers in the city, better use of the facility as it is at the gateway to downtown area, and how centers use city services including ambulance services. Commissioners contemplated continuing this matter to a future meeting so that staff could review the proposed traffic circulation plan.

Motion was made by CIRCO, seconded by SOTTILE, adopt the Resolution approving the appeal of the denial of the Director's decision of Minor Use Permit No. 4, adding a condition that a traffic circulation plan be approved by the City's Traffic Engineer, carried 4-1 (LONGORIA, no).

The appeal deadline is at 5 p.m., Friday, May 26, 2017. The resolution will be brought to the Planning Commission at its June 20, 2017 meeting for confirmation.
