## March 13, 2018

A Regular Joint Meeting of the El Cajon City Council/Housing Authority/Successor Agency to the Redevelopment Agency of the City of El Cajon, California held Tuesday, March 13, 2018, was called to order by Mayor/Chair Bill Wells at 3:01 p.m., in the Council Chamber, 200 Civic Center Way, El Cajon, California.

1.7 ACCEPTANCE OF PETSMART CHARITIES, INC. GRANT (Report: Dirk Epperson, Director of Public Works)

**RECOMMENDATION:** That the City Council ratifies a grant agreement with PetSmart Charities for \$50,000.00 and appropriates the grant for the purchase of spay and neuter equipment for the new El Cajon Animal Shelter, and authorizes related transfers.

**Debbrah Reeves** spoke in support of Rent Control.

**Jim Cirigliano** provided Council with an update on the rent mediation efforts for Mobile Home Park – Villa Novia.

**JC** stated that his constitutional rights have been violated.

**Carol Carroll**, owner of Carol's Daycare, stated that having a marijuana dispensary near her business is detrimental for her customers and neighborhood. She provided pictures for Council.

**City Manager Williford** stated that the store on Washington Avenue, near Ms. Carroll's business should not be open much longer as the City has been going through the legal process to close it down.

**Councilmembers** spoke in support of closing the existing marijuana stores.

Eric Lund praised the City Council and Staff for supporting the opening of the Marriott Hotel in the City.

Mayor Pro Tem Kendrick stated that the combination of the new Marriott Hotel and

the future opening of the East County Performance Arts Center (ECPAC)

Harold Brown spoke about a fundraiser scheduled for May 5, 2018. Monies will be

used for new buildings at the East County Transitional Living Center (ECTLC).

**Brenda Hammond** spoke of the benefits of exercising to music.

Larry Schulte spoke about making sewer payments online. He thanked staff for helping to get the property at Main Street & Greenfield Ave. cleaned up. Mr. Schulte complimented the Recreation Guide, which included important numbers for the City. He suggested including non-emergency numbers for the Police Department and Fire

Departments.

City Manager Williford gave credit to Dave Richards for leading the publication of the Recreation Department, along with people from the different City departments.

Bonnie Price suggested adopting an Ordinance to regulate rent control in Mobile

Home Parks in the City.

Stephanie Parker spoke in support of rent control in the City, which could prevent

homelessness.

**City Manager Williford** provided a summary of the Item, and introduced Dan Pavao, Building Official who gave a detailed report of the apartment inspection program.

Discussion ensued among **Council** and Inspector LC Wright concerning the following:

- The use of Sector Maps for inspections;
- Tenants calling to request inspections;
- Yearly reviews for recurring offenders.

# 4.2 UPDATE ON CITY OF EL CAJON'S HOMELESS STRATEGIES (Report: Graham Mitchell, Assistant City Manager)

**RECOMMENDATION:** That the City Council considers an update regarding the City's homeless programs implemented in 2017, and provide direction on any changes to those programs.

#### DISCUSSION

Assistant City Manager Graham Mitchell provided a summary of the Item and introduced Karina Hernandez, Housing Navigator for Crisis House, Captain Sean Kelsey from Salvation Army El Cajon Corps, and Eric Lund from the East County Chamber of Commerce. Each of them provided an update of the continued efforts on the homeless strategies.

**Eric Lund** introduced **Anna Marie Piconi Snyder**, new Coordinator Director for the East County Homeless Task Force. Ms. Piconi Snyder shared information on the East County Food Resources Programs.

Discussion ensued among **Council** and Inspector LC Wright concerning the following:

- Suggestion to add a sign below the current anti-panhandling sign, which would provide the homeless population information to get help;
- Suggestion to post larger anti-panhandling signs, when replacing by attrition;
- Request for data providing what the results of the current efforts have been;
- Suggestion to post signs near the freeway exits.

#### **ADMINISTRATIVE REPORTS: (Item 4.2 – Continued)**

**David Chenowetch** stated that sub-committees should have been formed to review homeless strategies. He stated that the strategic plan divides the community, and disagrees with signage that directs the homeless community to one non-profit group while excluding the rest of the non-profit opportunities. **Mr. Chenoweth** encouraged the City Council to create a sub-committee to avoid making haste mistakes in the future.

Stephanie Harper was not in the Council Chamber when called to the podium.

City Manager Williford clarified that a Motion and a Vote were required to incorporate the changes made by Councilmember Goble and Mayor Pro Tem Kendrick to Staff's Recommendation.

MOTION BY GOBLE, SECOND BY KENDRICK, to DIRECT, and using Staff's discretion design a larger Anti-Panhandling sign with the additional sign as directed by Council.

Motion was postponed when further questions were raised by **Councilmember Kalasho.** 

**Councilmember Kalasho** suggested adding a similar sign to Police Vehicles to provide information to the homeless population.

Mayor Wells suggested voting on the motion on the floor and then proceeding with discussion on the idea brought forward by Councilmember Kalasho.

MOTION BY GOBLE, SECOND BY KENDRICK, to DIRECT, and using Staff's discretion, to design a larger Anti-Panhandling sign with the additional sign as directed by Council.

#### MOTION CARRIED BY UNANIMOUS VOTE.

**Mayor Wells** suggested directing Staff to investigate the regulations of posting signs on Police cars.

City Manager Williford agreed with Mayor Wells, and he suggested bringing back information for City Council to consider.

**Councilmember Kalasho** stated that posting a removable sign on Police cars would reach more people than posting a sign.

MOTION BY KALASHO, SECOND BY McCLELLAN, to DIRECT Staff to perform study on adding temporary signs to Police Vehicles, and present findings to City Council.
