SUBJECT: City Council Appointment

RECOMMENDATION:

That the City Council appoints an eligible candidate to fill an "at-large" vacancy on the City Council with a term through November 2020.

BACKGROUND:

On March 27, 2019, a vacancy was created on the City Council. On April 9, 2019, the City Council determined that it would fill the vacancy through an appointment. It also established a period to accept applications and set May 14, 2019, 7:00 P.M. as the date and time to make the appointment. The appointment will fill an "at-large" seat on the City Council through November 2020. State law requires that the vacancy be filled by May 26, 2019. During its May 14th meeting at 3:00 P.M., the City Council will identify the method by which candidates will be considered for the appointment.

The City received applications from twenty-two eligible candidates. The applications are included with this staff report and are listed in alphabetical order. Additionally, two non-residents and one individual who is not a registered voter submitted applications—the applications for these individuals have not been distributed.

Staff recommends that the City Council follows its determined selection process and then makes the appointment.

BUSINESS:

El Cajon needs strong leadership, ready for the challenges facing our wonderfully community. We must be fiscally responsible. I'll keep a close watch on spending, and be sure the budget remains balanced. El Cajon needs new businesses. New business expands the tax base, keeps taxes down, creates jobs, and keeps our city thriving during tough times. As a small business owner, The Wrangler Family Barbecue, I understand the challenges facing our local businesses.

The council has done a great job attracting new businesses such as the Marriott Hotel and recently opened, and the Mercedes Benz dealership. Bringing new business to El Cajon increases the tax base, increases spending in the city, and provides new job and opportunities for the residents of El Cajon. Another great project is the current construction of a new Hampton Inn, In and Out Burger, Starbucks and other small shops in a small shopping center at 67 and Fletcher Parkway. Also, the reopening of the East County Performing Arts center will bring in revenue for the City, as well as the surrounding businesses in the downtown district. We must be sure that projects like these continue in the future.

I would also like to see the city work to promote the training and hiring of veterans. Being a Vietnam Era Veteran, American Legion member, and having served on both the City of El Cajon Veterans Commission and East County Chamber of Commerce Veterans Roundtable, I would encourage business owners to hire and train veterans. With nearly 10% of our residents being veterans, we need to do all that we can to help support those that served us.

HOMELESSNESS:

This is the most obvious problem that we face. In that it is out in the open and our residents, and visitors to our city see it each and every day. The homeless roam our streets setting up camps and leaving their refuse behind, use drugs, and commit crimes in our city. But that's just the tip of the iceberg, the part that we can see. This group of the homeless, for the most part, have chosen to live outside the lines of everyday society as a way of life. There is not much that can be done to change them. They have decided to ultimately live outside of normal society as they do. Those homeless must be dealt with under our laws to the full extent possible if they commit crimes. We must support our police department's efforts to enforce laws when broken. We must support the efforts of local organizations such as The East County Homeless Task Force, East County Transitional Living Center, and Crisis House just to name a few. Organizations such as these stand ready to help the homeless if they want to be helped, and we must continue to support these groups, and others like them. I have worked with the three aforementioned organizations during my time on the City of El Cajon Veterans Commission, and I stand ready to continue my personal support.

That being said, there is a different type of homelessness that must be addressed. That is the homeless that are trying to get back on their feet after a family crisis, such as the lost of a job, the loss of the primary wage earner through death or disability, or another event which causes a family, or individual to find themselves on the street, sleeping in their car, moving from relative to relative, or couch surfing on a nightly basis. This is the *Invisible Homelessness* and it is real, and it causes suffering for the entire family. I had to deal with a family that lost their rental home because the father lost his job, and they could no longer pay the rent. The father had a service related disability from his time in the US Navy. The school district informed me of the issue as I was serving on the Veterans Commission at the time. There was a child attending a local high school and was a senior. The child wanted nothing more than to graduate with her classmates. Through coordinated efforts contacting local agencies, we were able to place the family in a matter of weeks and the child graduated with her class. We must continue to resolve situations such as this, and I will continue to support those efforts whole heartedly.

POLICE and FIRE DEPARTMENTS:

Our city has grown over the years, and crime has grown with it. According to some recently published public data, the chance of an individual becoming the victim of a violent crime in El Cajon is 1 in 220, which is a bit higher than California as a whole, where the chance is 1 in 223. Violent crime was defined as murder, robbery, rape, or assault. Chances of being the victim of property crime in El Cajon is 1 in 40, which is a bit higher than California as a whole at 1 in 44. Overall crime per square mile in El Cajon is 194 crimes per square mile, while California as a whole is 88 crimes per square mile. More and more gang members are moving into our neighborhoods and this brings drugs, violence, and general crime to our streets. Some members of gangs such as the Locos, East County Boys, and Orphans just to name a few. They fight each other for territory, they will commit robbery and assault. Just this past March, a 19 year old gang member was sentenced to 14 years in prison for the 2017 stabbing death of an El Cajon resident (timesofsandiego.com). These gangs intimidate our residents, bully our children, and recruit members from our neighborhoods. Not only does gang activity affect our residents, but potential home buyers, or someone considering starting/relocating a business to El Cajon MUST consider gang activity, and they may decide to go elsewhere. This is bad for El Cajon financially, in that the tax base is not increased, money is not spent in the local community, and jobs will not go to the potential business. We must continue to support the efforts of our Police Department's efforts to combat all crime. With only 126 officers having been budgeted for the FY 2018-2019 (https://www.cityofelcajon.us/home/showdocument? id=18876) we must commend the men and women for the work that they do each and every day for the residents of El Cajon.

Our Fire Department took somewhere in the neighborhood of 15,000 calls for service last year. Nearly 13,400 of those calls were medical or accident related. This was a 6.5% increase from the previous year. Our Fire Department's 60 firefighters work diligently to service the residents of El Cajon. We must support them, and provide them with the resources they require to keep our community safe. I will support any efforts of the council to provide our Fire Department with equipment, training, etc. they may need. (https://www.cityofelcajon.us/home/showdocument?id=18876)

- 1. Completion of development projects in a timely manner. I would support activity by the Council to encourage City Staff to work with developers in the City to refrain from starting projects that they are not prepared to complete, in order to reduce the length of time City assets like streets and sidewalks are in a temporary condition (such as under traffic plates).
- 2. Municipal Cleanup / Redevelopment / Business Improvement The areas of downtown around Main & Magnolia and the new work at Broadway and N. Magnolia are examples of success in improving the appearance and safety of business areas while providing economic opportunity for the City. I would promote policies and action by the City to extend this type of redevelopment activty outward, especially along Jamacha from Main to the 8, and on Broadway between Jamacha and the 67. These areas, and others, offer great opportunity for relatively minor changes in infrastructure, coupled with effort by private industry, to create new, walkable shopping and restaurant areas similar to downtown which will improve quality of life in the City.
- 3. Homelessness / Poverty / Social Services The prevalence of homeless individuals in our community, as well as issues surrounding the working poor / those living in poverty who are not (or not yet) homeless is a substantial concern for all residents of the city, both from an humanitarian aspect as well as an economic one. I would support policies and action by the City to improve access to existing services already on offer, and I would work to collaborate with the County of San Diego and neighboring cities to work together to adopt solutions that reduce homelessness and the negative social effects of poverty without undue strain on municipal budgets. Additionally, I would be a strong advocate for mixed development (containing both market rate and affordable / subsidized housing), and policies which favor controlled in-fill development (such as accelerated permitting for auxiliary dwelling units). I would also support policies such as working with MTS to adjust transit routes to improve access to services for those in need, supporting existing not-for-profit service organizations in the community, and providing training to City staff to assist impacted individuals in accessing services in the community to get back on their feet.
