CORDOVA and DEVINE summarized the staff report through a PowerPoint presentation. Staff recommended that the Planning Commission adopt the proposed resolution recommending City Council certifying the Environmental Impact Report No. 91 and approving the Climate Action Plan.

Mr. Hatem MOHTASEB, representing the Partnership for the Advancement of New Americans (PANA), stressed the importance of affordable housing and having housing near employment centers.

Ms. Maleeka MARSDEN noted that affordable housing be located near transit, and having 100% clean energy goals instead of 80%, enforceable measures and a social equity section.

Ms. Hannah SANDERS, an intern with Climate Action Campaign, encouraged a progressive climate Action Plan, 100% clean energy goals, more trees, and social equity in the plan

Mr. Dennis SELDER recommended that the Forrester Creek Project and its benefits be incorporated into the Climate Action Plan.

Motion was made by MROZ, seconded by SOTTILE, to close the public hearing; carried 4-0.

Commissioners requested that a supporting measure be added to develop a tree preservation and replanting ordinance.

Motion was made by CIRCO, seconded by MROZ, to adopt the proposed resolutions recommending City Council adopt the findings and certify the Final Environmental Impact Report No. 91, and recommending City Council Approval of the Climate Action Plan as amended with the addition of the tree preservation and replanting measure; carried 4-0.

COMMUNICATIONS:

DEVINE, in a presentation using the Development Projects' Story Map available on the City's website, gave updates on the Sears project, PACE Center, Mazda of El Cajon and Marshall Avenue storage. She added the City will be accepting applications for the Planning Commission vacancy. The deadline is 4:30 p.m., June 27 and applicants will be interviewed on July 9, 2019 at 7:00 p.m. She added that In-N-Out restaurant on Fletcher Parkway will have a Grand Opening on June 20, 2019.
