- Current escrow time lines;
- Date changes to the original proposal to Crisis House; and
- Lease v. purchase options for Crisis House.

- Consideration to provide the \$700,000 incentive as a down payment if property is vacated by 12/31/2020, escrow on new property is closed by 08/02/2021, with a contingency that if escrow fails, the city would collect the funds provided;
- Current Crisis House property appraised at \$1.2 million dollars; and
- Timeline 'best and final offer' agreement by Crisis House.
