

#### **BACKGROUND:**

The Debris Collection Services contract provides for the removal of trash, debris, abandoned furniture, and other items designated throughout City limits.

On November 10, 2020, City Council approved rejecting all bids and authorized re-bidding the project with revised specifications.

This bid was advertised on February 11, 2021. Three responses were received at 2:00 p.m. on March 10, 2021, and all bids were evaluated.

The bid specifications required all bidders to submit a bid security in an amount not less than 10% of the bid amount. The cashier's check submitted by the second low bidder, ECTLC, was less than the required 10% of the bid amount.

Additionally, LMA submitted a written protest dated March 17, 2021. The protest was received within the time frame provided and is deemed timely. LMA's protest stated that the first and second low bidders, UCSDC and ECTLC, respectively, were non-responsive for failure to register with the Department of Industrial Relations (DIR) and did not intend to pay prevailing wage for the required scope of work.

As stated in the bid specifications, this public project is subject to registration, compliance monitoring, and enforcement by the DIR. Therefore, the first and second low bidders were provided an opportunity to submit proof of DIR prevailing wage-exempt status.

The first low bidder, UCSDC, submitted a letter from the California Conservation Corps stating UCSDC meets all certification requirements and is certified as a Community Conservation Corps for the term July 1, 2020, through June 30, 2021. In accordance with California Public Resources Code Section 14507.5 and California Labor Code 1720.4, work performed by certified members of the California Conservation Corps are exempt from paying prevailing wages and are exempt from DIR registration. Furthermore, UCSDC submitted an email from the DIR stating that UCSDC was exempt from paying prevailing wages and registration requirements. As to LMA's protest of an award to UCSDC on the basis that UCSDC is not exempt from the payment of prevailing wages, City staff finds LMA's protest without merit.

The second low bidder, ECTLC, submitted California Form 3500A, Submission of Exemption Request. ECTLC does not qualify for the exemption status based on their non-profit, tax-exempt status. City staff finds LMA's protest with merit. Therefore, ECTLC is considered non-responsive for failure to register with the DIR and providing a bid security in an amount less than 10% of the bid amount.

Staff recommends that the City Council rejects the bid of ECTLC as non-responsive and awards the bid to the lowest responsive, responsible bidder, UCSDC, in the amount of \$107,700. The summary of bids is attached, and complete proposals are on file in the Purchasing Division. For comparison purposes, staff analyzed the cost of providing the scope of work with City staff. Staff determined that personnel costs would range between \$115,000 and \$130,000 annually, along with vehicle, fuel, and miscellaneous cost of approximately \$22,500.

#### FISCAL IMPACT:

The fiscal impact for the initial one-year term is \$107,700. Sufficient funds are included in the proposed Fiscal Year 2021-22 Public Works – Street Operations (211320) budget, contingent upon City Council approval. Subsequent 4-year costs are estimated to total \$487,410.

WHEREAS, as stated in the bid specifications, the Project, as a public project, is subject to registration, compliance monitoring and enforcement by the DIR; and

WHEREAS, the first and second low bidders were provided an opportunity to submit proof of DIR prevailing wage exempt status; and

WHEREAS, in accordance with California Public Resources Code section 14507.5 and California Labor Code section 1720.4, work performed by certified members of the California Conservation Corps (the "CCC") are exempt from paying prevailing wages, and as such, are exempt from DIR registration, and

WHEREAS, UCSDC submitted a letter from the CCC stating that UCSDC meets all certification requirements and is certified as a Community Conservation Corps for the term of July 1, 2020 through June 30, 2021; and

WHEREAS, UCSDC also submitted an email from the DIR stating that UCSDC was exempt from paying prevailing wage and registration requirements, and therefore, City staff finds LMA's protest of UCSDC without merit; and

WHEREAS, ECTLC submitted California Form 3500A, Submission of Exemption Request, but does not qualify for the exemption status based on their non-profit, tax exempt status, and therefore, City staff finds LMA's protest deserving of approval, and ECTLC is considered non-responsive for failure to register with the DIR and providing a bid security in an amount less than 10% of the bid amount; and

WHEREAS, staff recommends that the City Council rejects the bid of ECTLC as non-responsive, and awards the bid to the lowest responsive, responsible bidder, UCSDC, in the amount of \$107,700; and

WHEREAS, the City Council believes it to be in the best interests of the City to award the bid to the sole responsive, responsible bidder, in the amount of \$107,700.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL CAJON AS FOLLOWS:

- 1. The above recitals are true and correct, and are the findings of the City Council.
- 2. The City Council hereby finds the protest submitted by LMA regarding UCSDC timely, but without merit.

**SUBJECT:** Delinquent Refuse Collection Charges

#### **RECOMMENDATION:**

That the City Council:

- 1. Opens the Public Hearing and receives public testimony;
- Closes the Public Hearing;
- 3. Adopts the next Resolutions, in order, confirming the list of property owners as delinquent in the payment of their mandatory trash service bills; and
- 4. Authorizes the City Clerk to record the amount owed as a lien on the property and forward the list to the County Tax Assessor for billing on the next property tax bill.

#### **BACKGROUND:**

On January 1, 1996, the City began mandatory trash service for all single-family residences. The City's agreement with its solid-waste hauler at that time, Waste Management, allowed Waste Management to bill for regular service, with the City assuming responsibility for placing liens on delinquent accounts. Once collected through the tax lien process, the City is then obligated to remit the funds collected to Waste Management. This allows the City to use the enforcement power of a property lien, when necessary, to collect past due amounts. Additionally, the lien process is a cost-effective way for the City to ensure payment of delivered services.

This is the final lien process for Waste Management, as they are no longer the City's franchise hauler. Attached is the list of properties that are delinquent in payments for refuse and recycling collection services provided through December 2020. Property owners have several opportunities before the lien process to reconcile their accounts, including advanced notice of the public hearing. In addition, accounts can be settled by providing payment of their delinquent balance up to the day of the City Council meeting.

The El Cajon Municipal Code allows for exemption from the mandatory refuse service with sufficient proof of use of a City-approved refuse and recyclables collection alternative. Residents may take their refuse to their private business located within the City limits of El Cajon, or they may haul their refuse to the landfill and provide receipts for such service.

The City is contractually obligated to assist Waste Management with the collections process as dictated in our Franchise Agreement and Municipal Code. Therefore, this is the final list of delinquent accounts for Waste Management for the last billing cycle (September 2020) of their contract with the City that expired on 12/31/2020.

On April 19, 2021, 487 customers were sent a Final Notice of Delinquency, asking them to pay a combined total of \$74,102.05. As of May 21, 2021, there are 366 delinquent accounts for the City Council to consider totaling \$55,524.08.

#### FISCAL IMPACT:

As the City collects a 15% franchise fee for Waste Management services, the City's financial share of these delinquencies is approximately \$8,328.61.

List of Delinquent Refuse Collection Accounts is available for review in the City Clerk's Office during regular business hours.

In accordance with the provisions of Title 4, Division 3, Chapter 10, section 38791 and Title 3, Division 2, Chapter 8, section 25831 of the Government Code of the State of California, and section 8.24.090 of Chapter 8.24 of the El Cajon Municipal Code, the report and account of delinquent refuse collection service fees and charges (Exhibit "A") considered at the hearing held on May 25, 2021, on file in the office of the City Clerk, is approved, and the unpaid amounts designated in said report and account shall be a charge to the owners of the properties on the next regular tax bill, and shall be liens upon the properties involved.
- 2. The sums herein assessed remaining unpaid after thirty (30) days from the date of this resolution shall bear interest at the rate of seven percent (7%) per annum, as set forth in section 8.24.100 of Chapter 8.24 of the El Cajon Municipal Code.
- 3. The designation of said parcels is shown by Assessor's parcel numbers, and the initial amounts plus interest to be assessed and imposed as liens are designated thereafter on Exhibit "A," on file in the Office of the City Clerk.
- 4. Said liens shall be of no further force or effect upon the confirmation of the Tax Collector that said assessments have been added to the tax rolls.
- 5. The City Clerk is hereby directed to record one or more certified copies of this resolution, which shall collectively include all of Exhibit "A," in the office of the County Recorder of San Diego County.
- 6. The City Clerk is hereby authorized to discharge and release any such lien when the claim under said lien has been fully satisfied.
- 7. The decision in your matter is final on this date, and by this notice, you have 90 calendar days from the date of the mailing of this notice to seek judicial

#### BACKGROUND:

Local SANDAG TransNet regulations require the City to hold a public meeting regarding any proposed amendments to the five-year Regional Transportation Improvement Program (RTIP). TransNet is the countywide half-cent sales tax for local transportation projects that was first approved by voters in 1988, and extended in 2004 for another 40 years. The current five-year 2021 RTIP was formally adopted by City Council on May 26, 2020. The RTIP is a prioritized capital improvement program designed to implement the region's overall strategy for providing mobility and improving the efficiency and safety of the City's transportation system. The City receives approximately \$2.5 million annually in TransNet funds for transportation capital improvement projects.

This proposed amendment includes the following changes to the existing RTIP programmed list of projects:

- 1. Increase funds in the (EL03) Street Overlay account by \$1,819,000.00 for current and new projects. Reallocate \$616,510.00 (PW3613 & PW50018) in surplus funds from past fiscal year completed projects back into this account. This annual paving program provides for the re-paving of local and major streets within the City in conjunction with the Pavement Management Program that prioritizes streets based on their existing pavement condition.
- 2. Increase funds in the (EL06) Traffic Signals account by \$130,000.00 for current and new projects. Reallocate \$6,770.00 (PW3617) in surplus funds from past fiscal year completed projects back into this account. This annual traffic signal program provides for the upgrade and modification of the City's traffic signal system to improve traffic flow and

safety.

- 3. Increase funds in the (EL11) Sidewalk Improvement account by \$900,000.00 for current and new projects. Reallocate \$75,202.00 (PW3405 & PW52019) in surplus funds from past fiscal year completed projects back into this account. This annual sidewalk improvement program repairs damaged sidewalks, installs new sidewalks, and new curb and gutter at various locations throughout the City.
- 4. Increase funds in the (EL18) Street Light Installation account by \$478,000.00 for current and new projects. Reallocate \$448.00 (PW3617) in surplus funds from past fiscal year completed projects back into this account. This annual program installs new street lights and retrofits existing street lights with energy-efficient LED luminaires at various locations throughout the City.
- 5. Transfer \$175,000.00 from the (EL21) Street Resurfacing account to the (EL11) Sidewalk Improvement account for current and new projects. This annual street resurfacing program rehabilitates (slurry seals) streets to prolong the life of existing pavement at various locations throughout the City.
- 6. Increase funds in the (EL29) Traffic/Safety Calming account by \$260,000.00 for current and new projects. Reallocate \$153,189.00 (PW3579, PW3491, PW3615, and PW3659) in surplus funds from past fiscal year completed projects back into this account. This annual program provides for the installation of new traffic safety calming measures such as street striping, enhanced visibility crosswalks, and radar speed feedback signs.
- 7. Close the (EL39) Bicycle Parking Enhancement project. The project is complete and installed new bicycle parking facilities at eight (8) Parks and Recreation centers in the City.

#### CALIFORNIA ENVIRONMENTAL QUALITY ACT:

The 2021 RTIP program of projects is categorically exempt from the provisions of the California Environmental Quality Act (CEQA), according to section 15301, Class 1(c) of the CEQA guidelines. Section 15301 contains an exemption for the maintenance of roadways.

#### FISCAL IMPACT:

The proposed transfer of TransNet funds does not impact any appropriations in the current Fiscal Year 20-21 budget, including the General Fund.

### RESOLUTION OF THE CITY OF EL CAJON AMENDING THE TRANSNET LOCAL STREET IMPROVEMENT PROGRAM OF PROJECTS FOR FISCAL YEARS 2021 THROUGH 2025

WHEREAS, the voters of San Diego County approved the San Diego Transportation Improvement Program Ordinance and Expenditure Plan (*TransNet* Extension Ordinance) in 1988, and extended it on November 4, 2004, for an additional forty (40) years; and

WHEREAS, the *TransNet* Extension Ordinance provides that SANDAG, acting as the Regional Transportation Commission, shall approve on a biennial basis a multi-year program of projects submitted by local jurisdictions identifying those transportation projects eligible to use transportation sales tax (*TransNet*) funds; and

WHEREAS, the current five-year 2021 Regional Transportation Improvement Program ("RTIP") was formally adopted by City Council of the City of El Cajon (the "City") on May 26, 2020; and

WHEREAS, the RTIP is a prioritized capital improvement program designed to implement the region's overall strategy for providing mobility and improving the efficiency and safety of the City's transportation system, and the City receives approximately \$2.5 million annually in TransNet funds for transportation capital improvement projects; and

WHEREAS, local SANDAG TransNet regulations require the City to hold a public meeting regarding any proposed amendments to the RTIP; and

WHEREAS, the City of El Cajon has held a noticed public hearing with an agenda item that clearly identified the proposed list of projects prior to approval of the projects by its authorized legislative body in accordance with Section 5(A) of the *TransNet* Extension Ordinance and Rule 7 of SANDAG Board Policy No. 31.

WHEREAS, City staff has recommended the proposed amendment to the RTIP, which does not impact any appropriations in the current Fiscal Year 20-21 budget, including the General Fund, and includes the following changes to the scheduled list of projects:

1. Increase funds in the (EL03) Street Overlay account by \$1,819,000.00 for current and new projects. Reallocate \$616,510.00 (PW3613 & PW50018) in surplus funds from past fiscal year completed projects back into this account. This annual paving program provides for the re-paving of local and major streets within the City in conjunction with the Pavement Management Program that prioritizes streets based on their existing pavement condition.

- 2. Increase funds in the (EL06) Traffic Signals account by \$130,000.00 for current and new projects. Reallocate \$6,770.00 (PW3617) in surplus funds from past fiscal year completed projects back into this account. WHEREAS, the 2021 RTIP program of projects is categorically exempt from the provisions of the California Environmental Quality Act ("CEQA"), according to section 15301, Class 1(c) of the CEQA guidelines, which contains an exemption for the maintenance of roadways.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL CAJON AS FOLLOWS:

- 1. Pursuant to Section 2(C)(1) of the *TransNet* Extension Ordinance, the City of El Cajon certifies that no more than 30 percent of its cumulative revenues shall be spent on local street and road maintenance-related projects.
- 2. Pursuant to Section 4(E)(3) of the *TransNet* Extension Ordinance, the City of El Cajon certifies that all new projects, or major reconstruction projects, funded by *TransNet* revenues shall accommodate travel by pedestrians and bicyclists, and that any exception to this requirement permitted under the Ordinance and proposed shall be clearly noticed as part of the City of El Cajon's public hearing process.
- 3. Pursuant to Section 8 of the *TransNet* Extension Ordinance, the City of El Cajon certifies that the required minimum annual level of local discretionary funds to be expended for street and road purposes will be met throughout the 5-year period consistent with the most recent Maintenance of Effort Requirements adopted by SANDAG.
- 4. Pursuant to Section 9A of the *TransNet* Extension Ordinance, the City of El Cajon certifies that it will exact \$2,635.50, plus all applicable annual increases, from the private sector for each newly constructed residential housing unit in that jurisdiction (unless exempted under the *TransNet* Extension Ordinance,) and shall contribute such exactions to the Regional Transportation Congestion Improvement Program (RTCIP).
- 5. Pursuant to Section 13 of the *TransNet* Extension Ordinance, the City of El Cajon certifies that it has established a separate Transportation Improvement Account for *TransNet* revenues with interest earned expended only for those purposes for which the funds were allocated.
- 6. Pursuant to Section 18 of the *TransNet* Extension Ordinance, the City of El Cajon certifies that each project of \$250,000 or more will be clearly designated during construction with *TransNet* project funding identification signs.
- 7. The City of El Cajon does hereby certify that all other applicable provisions of the *TransNet* Extension Ordinance and SANDAG Board Policy No. 31 have been met.
- 8. The City of El Cajon agrees to indemnify, hold harmless, and defend SANDAG, the San Diego County Regional Transportation Commission, and all officers and employees thereof against all causes of action or claims related to City of El Cajon's *TransNet* funded projects.
- 9. The City Council hereby approves the amendment to the current five-year 2021 Regional Transportation Improvement Program ("RTIP") that was formally adopted by the City Council on May 26, 2020, as recommended by staff.

**SUBJECT:** Remove Conditional Use Permit Requirement for Outdoor Dining on City

Sidewalks

#### RECOMMENDATION:

That the City Council introduces the next Ordinance, in order, removing the requirement for a Conditional Use Permit for outdoor dining and drinking on City sidewalks, and asks the City Clerk to read the ordinance by title only.

#### BACKGROUND:

At the onset of the COVID-19 pandemic it was immediately known that the impacts on local businesses were likely to be severe. The El Cajon City Council quickly realized the need to allow businesses permitted to be open to take advantage of outdoor areas, and on April 14, 2020, gave initial policy direction allowing businesses to operate outdoors in parking lots or other areas that were deemed safe and accessible. In a similar effort, on June 23, 2020, the City Council adopted Ordinance No. 5101 temporarily removing the requirement for a Conditional Use Permit (CUP) for outdoor dining and drinking on City sidewalks. Each of these City Council pro-business efforts have been extended in response to the ongoing pandemic with the City Council adopting a resolution allowing for the continued relaxation of certain Zoning Code standards until December 31, 2021, and with the adoption of Ordinance No. 5104 removing the CUP requirement for outdoor dining on City sidewalks until June 30, 2021. Please note that the use of City sidewalks still requires an encroachment permit issued by the Public Works Department.

#### DISCUSSION

The City Council has repeatedly made it clear that every effort must be made to keep El Cajon businesses going during the pandemic. Moreover, City Council discussions at their Goal Setting Workshop, and policy direction given in response to the American Rescue Plan, indicate the desire to remove economic development barriers where feasible.

In this case requiring a CUP delays the issuance of an encroachment permit as it would require: an additional application with the payment of a fee; CEQA review; consideration of a recommendation of approval by the Planning Commission; and approval by the City Council. By eliminating the need for a CUP the City is not only providing assistance through economical means, but is assisting in re-opening eating and drinking establishments and attracting new ones. This proposed ordinance does not remove the need for an encroachment permit, which provides safeguards for the City through the requirements that the business provides insurance

with appropriate additional insured endorsements, as well as a hold harmless agreement. However, Public Works staff can easily process applications working personally with the applicant and assist in meeting the conditions remaining in El Cajon Municipal Code Chapter 12.09, without the need to wait for a CUP to be approved.

Therefore, it is recommended that the City Council approve and introduce the first reading of the regular ordinance, which will then return for second reading and adoption at the June 8, 2021 City Council meeting.

# AN ORDINANCE TO AMEND SECTIONS 12.09.030 AND 12.09.060 OF THE EL CAJON MUNICIPAL CODE TO ELIMINATE THE NEED FOR A CONDITIONAL USE PERMIT FOR SIDEWALK DINING IN THE CITY

WHEREAS, the City Council of the City of El Cajon (the "City") adopted Ordinance No. 5101 on June 23, 2020, to temporarily eliminate the need for a conditional use permit for sidewalk dining in the City for the period of June 15, 2020 through December 31, 2020; and

WHEREAS, the City Council extended the temporary elimination of the need for a conditional use permit for sidewalk dining in the City through June 30, 2021; and

WHEREAS, the elimination of the requirement for a conditional use permit will allow existing restaurants to fully re-open by utilizing city-owned sidewalks and other rights-of-way in order to offer eating and drinking services without the costly and time-consuming requirement of obtaining a conditional use permit; and

WHEREAS, the proposed ordinance amendment removes an economic development barrier in attracting new business, and enables existing businesses to grow.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF EL CAJON DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 12.09.030 of Chapter 12.09 of Title 12 of the El Cajon Municipal Code is hereby repealed.

SECTION 2. A new section 12.09.030 is hereby added to Chapter 12.09 of Title 12 of the El Cajon Municipal Code to read as follows:

#### 12.9.30 General provisions.

The general provisions for sidewalk dining are as follows:

- A. Sidewalk dining will only be allowed in commercial zones.
- B. Establishment of sidewalk dining shall require the issuance of an annual encroachment permit for sidewalk dining. Operators shall comply with all requirements of this chapter, and all conditions imposed by the encroachment permit.
- C. Operators of the sidewalk dining shall provide adequate public liability insurance in accordance with city council policy and to the satisfaction of the city attorney.

- D. There shall be no damage caused by the sidewalk dining to the paving or the existing features of the sidewalk.
- E. The sidewalk dining shall be adjacent to the operator's associated licensed establishment selling food and beverages for consumption on the premises. See section 12.09.050(F).
- F. The hours of operation of the sidewalk dining shall not extend beyond the hours of operation of the operator's associated eating and drinking establishment.
- G. Alcoholic beverages will only be available in conjunction with the food service at the sidewalk dining portion.
- H. The sidewalk dining portion shall be kept free of trash, food, and spills at all times.
- I. If there is a sound system in the sidewalk dining portion, it shall be limited to background music only, shall comply with all city noise regulations, and shall not be audible to pedestrians beyond ten feet of the sidewalk dining portion, nor vehicles.
- J. Pedestrians shall have the right-of-way where the food servers and customers have to cross or wait on the sidewalk area outside the sidewalk dining area.
- K. The sidewalk area shall be cleared of all encroachments for special events and maintenance work on the subject and adjacent properties. Some special events will require that the encroachments be removed prior to midnight of those events (e.g. Mother Goose Parade, etc.) in order to make the entire sidewalk available for pedestrians. Sidewalks must be cleaned and free of all trash, food, and spills, and made safe by the operator for pedestrian use when the encroachments are removed.
- L. Furniture may remain on the sidewalk in the public right-of-way outside the hours of operation only if approved by the city manager or his or her designee. Granting or withholding such approval shall be at the sole discretion of the city manager or his or her designee. Any approved fencing shall be subject to the design criteria set forth in section 12.09.050, herein.

SECTION 3. Section 12.09.060 of Chapter 12.09 of Title 12 of the El Cajon Municipal Code is hereby repealed.

SECTION 4. A new section 12.09.060 is hereby added to Chapter 12.09 of Title 12 of the El Cajon Municipal Code to read as follows:

#### 12.09.060 Permits and approval process.

Sidewalk dining must be approved by an encroachment permit issued by the public works department. The encroachment permit shall be an annual permit with new fees based on the city's costs paid each year. Renewal of the encroachment permit will be subject to the satisfactory compliance with the conditions of the encroachment permit. New conditions of approval of the encroachment permit will be subject to the approval of the city manager or his or her designee. The encroachment permit may be revoked upon thirty days written notification to the operator and will be subject to appeal to the city manager and, if necessary, to the city council. Notwithstanding the foregoing, the revocation of the encroachment permit may be effective immediately upon written notification of any violation which endangers the public safety, health, and welfare as determined by the city manager or his or her designee. In such event, the sidewalk dining area shall be posted with a notice that it shall not be occupied until such time as the area is determined safe for further occupancy.

SECTION 5. This ordinance shall go into effect thirty (30) days following its passage and adoption.

#### RECOMMENDATION:

Staff recommends that the City Council:

- 1. Opens the Public Hearing and receives public testimony;
- 2. Closes the Public Hearing; and
- 3. Adopts the next Resolution, in order, amending the FY 2019-20 One-Year Action Plan to:
  - a. Allocate and appropriate \$500,000 in CDBG-CV3 funds for continuation and/or expansion of programs for existing emergency shelter and refined emergency motel stays for homeless persons and families to prevent the spread of the coronavirus;
  - b. Allocate and appropriate \$10,000 in CDBG-CV3 funds for a new program to provide home-delivered, medically-tailored meals for critically ill persons and families to prevent the spread of the coronavirus;
  - c. Allocate and appropriate \$299,307 in CDBG-CV3 funds for a project to acquire and/or rehabilitate a facility for the provision of shelter for homeless persons and families to prevent, prepare for and respond to the coronavirus; and
  - d. Authorize the City Manager, or designee, to make the necessary adjustments or corrections to the One-Year Action Plan, execute all affiliated documents, and submit all required documentation to the U.S. Department of Housing and Urban Development.

#### BACKGROUND:

The Coronavirus Aid, Relief, and Economic Security Act ("CARES Act") was signed into law on March 27, 2020. The CARES Act made additional Community Development Block Grant Coronavirus funds available from the U.S. Department of Housing and Urban Development ("HUD") to prevent, prepare for, and respond to the impacts of the coronavirus. The funds are limited to serving primarily low- and moderate-income (LMI) residents.

In April/May of 2020, HUD allocated \$802,656 to the City in the first round of CARES Act funding (referred to "CDBG-CV"). The City Council authorized allocation of \$572,362 for rental and utility assistance and \$230,294 for emergency shelter programs for the homeless.

On September 11, 2020, HUD allocated an additional \$1,009,307 in the third round of funding (referred to as "CDBG-CV3") (the second round of CDBG-CV funding was provided directly to states). Last October, the City Council authorized allocation of a portion of the CDBG-CV3 funds for continuation of the motel voucher program (\$100,000) and rental/utility assistance (\$100,000) program once the first round of funds was spent. Those allocations were formalized in a public hearing on January 12, 2021.

As of April 30, 2021 (the most recent data available), the CDBG-CV and CDBG-CV3 programs have performed as follows:

On April 13, 2021, following an update on homeless programs, the City Council received public input and provided direction to staff for the continuation of programs addressing homelessness in the City using CDBG-CV3 and other funds budgeted. In addition, direction was given to continue to work, through the East County Homeless Task Force, on regional efforts to address homelessness. The Task Force plays a role in coordinating efforts and helping to understand the needs of the homeless service agencies and community partners. Through the task force, staff is working with neighboring jurisdictions (including the County) on a regional approach to jointly address homelessness in East County.

Based on direction given by the City Council, and staff's analysis of existing programs and needs in the community, staff recommends allocating the remaining \$809,307 in CDBG-CV3 funds for programs to assist homeless El Cajon residents in preparing for, preventing or responding to coronavirus as follows:

- a. <a href="Home Start">Home Start</a>, Inc.: Emergency Shelter Scatter-Site Motel Program</a> will provide emergency motel room vouchers, housing placement and emergency housing assistance for homeless families and individuals impacted by COVID-19 that are housing-focused and housing-ready, with the goal of attaining permanent housing. Home Start estimates that 50 homeless households will benefit from this program. Staff recommends funding this activity with CDBG-CV3 funds in the amount of \$400,000.
- b. <u>East County Transitional Living Center</u>: Emergency Shelter Program will continue to provide emergency shelter, case management and food resources for homeless families and individuals. This funding is expected to act as bridge funding to ensure that the shelter remains open and available throughout the year, once the regular allocations of CDBG funds are exhausted. ECTLC estimates that 300 additional homeless individuals will benefit from this program. Staff recommends funding this activity with CDBG-CV3 funds in the amount of \$100,000.
- c. <u>Mama's Kitchen</u>: Home-Delivered Meals Program will deliver medically-tailored meals for critically ill clients and their dependent children. These clients' health status puts them at higher risk of complications from COVID-19 if they were to become infected. Mama's Kitchen estimates that 35 LMI El Cajon residents will receive approximately 6,750 meals with this funding. Staff recommends funding this activity with CDBG-CV3 funds in the amount of \$10,000.
- d. <u>City of El Cajon</u>: Acquisition and/or Rehabilitation of Facility for Homelessness. Staff recommends allocating the balance of the CDBG-CV3 funds (\$299,307) for assisting in the acquisition and/or rehabilitation of a facility for shelter or navigation center. The funds will likely be leveraged with other available funding (potentially with other jurisdictions). The funds will be set aside until an appropriate facility, operator and funding source are identified, and must be expended within a three-year timeframe. Staff expects to return to City Council with a plan for further discussion and direction once a project is identified and additional details are known.

Notice of this Public Hearing and Minimum 5-Day Public Review and Comment Period was published in the East County Gazette, and posted online and in multiple locations, on May 13, 2021, providing citizens with the opportunity to comment on and to participate in the proposed Third Amendment to the FY 2019-20 One-Year Action Plan. Furthermore, the draft Third Amendment was posted on the City's website on May 13, 2021. The 5-day notice and comment period were provided in accordance with the emergency provisions of the City's adopted Citizen Participation Plan in order to allocate the funding for services as quickly as possible in response to the coronavirus pandemic. As of the date of publication of this Agenda Report, no comments have been received. Any comments received will be incorporated into the final document.

Staff recommends adopting the Third Amendment to the FY 2019-20 One-Year Action Plan allocating and appropriating the funding for the activities as outlined above.

#### FISCAL IMPACT:

All CDBG-CV3 grant allocations will be utilized to fund eligible projects and program costs pursuant to Federal law. There is no impact to the General Fund. This action increases the total CDBG appropriation for the FY 2019-20 One-Year Action Plan by \$809,307 due to the increased CARES Act CDBG-CV3 funding.

The public review and comment period has been reduced in order to quickly distribute the funds into the community. HUD has granted the City of El Cajon a waiver allowing for this reduction in public review and comment period. A public hearing will be held on Tuesday, May 25, 2021 at 3:00 P.M. in the El Cajon Council Chambers at 200 Civic Center Way, El Cajon, CA 92020. The following activities are recommended by staff for funding:

#### **RECOMMENDATION:**

That the City Council:

- 1. Authorizes the appropriation of up to \$3,500,000 of Proposition O funding for the Fire Station 7 Project (PS0051);
- 2. Authorizes the de-appropriation of unexpended amounts of Proposition O funding related to the Public Safety Efficiency Improvements Project (PS0071);
- 3. Authorizes the appropriation and transfer of \$3,235,000 of General Fund Reserves to the City Capital Improvement Program Fund (501); and
- 4. Authorizes the appropriation of \$3,235,000 to reestablish the Public Safety Efficiency Improvements (IFM3740) project.

#### **BACKGROUND:**

In November 2004, Proposition O was approved by the voters implementing a ½ cent sales tax increase for ten years to improve public safety infrastructure, including building a new public safety facility and a new animal shelter. This proposition also formed the Public Safety Facility Financing Oversight Committee (PSFFOC) to monitor the use of these funds. This sales tax measure concluded in 2015, but residual balances continue to fund a number of active projects.

On May 4, the PSFFOC met to swear in new Committee members, discuss active projects, as well as consider outstanding needs. One such need identified was Fire Station No. 7, which is the only station without significant upgrading during the life of Proposition O. This station has been in need of remodeling and expansion for quite some time. The existing Fire Station was constructed in 1960 and has not experienced any significant updates since its initial construction aside from maintenance. According to the Fire Department, the biggest two challenges are the lack of accommodation for male/female staff and an apparatus bay that is much too small to properly fit a modern fire apparatus. The existing station currently houses only one open dormitory and one communal bathroom, which pose challenges for staff. The existing apparatus bay can only house one small fire truck and its bay door size limits its use.

This project is an ideal candidate for the use of Proposition O funding; however, there is currently insufficient uncommitted funding for this project. One active project, the Public Safety Efficiency Improvements (PS0071) project, was identified as a candidate for alternative funding. This \$3.0 million project was originally budgeted in Fiscal Year 2020. This project's goal is to provide an additional layer of energy resiliency for the Public Safety Center, as well as to

generate operational cost savings. After a thorough discussion between the PSFFOC and City staff, the group concluded that the renovation of Fire Station No. 7 represents a better opportunity to highlight the responsible use of the Proposition O funding. Additionally, this project would be a fitting capstone of a multi-year endeavor that built the Public Safety Center, the Animal Shelter, and with the approval of this report's recommendations, significantly upgraded all four City fire stations.

The goals of the Public Safety Efficiency Improvements project remain relevant. Due to the cost savings (this project will generate approximately \$250,000 annually), staff recommends continuing the project and using General Fund Reserves to replace the Proposition O funding for this project. Staff will return to the City Council for a more detailed report of this project and its projected savings.

The recommendations included in this report establish the Fire Station No. 7 Renovation Project, funded by Proposition O proceeds. Also recommended is canceling the Proposition O funded Public Safety Efficiency Improvements (PS0071) project and appropriating a similar project in the City Capital Improvement Program Fund (501). To fund this new project, the appropriation and transfer of General Fund Reserves are also recommended.

#### CALIFORNIA ENVIRONMENTAL QUALITY ACT:

The proposed project is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) according to section 15301 (Class 1) (a) of the CEQA Guidelines. Section 15301 (Class 1) (a) provides an exemption for interior or exterior alterations on existing facilities involving such things as partitions, plumbing, and electrical conveyances.

#### FISCAL IMPACT:

As a result of this action, total Public Safety Facilities Fund (502) appropriations will increase approximately \$470,000. Additionally, City Capital Improvement Program Fund (501) appropriation will increase approximately \$3.2 million, funded by the use of General Fund Reserves.

**SUBJECT:** Redistricting Process Update

#### **RECOMMENDATION:**

That the City Council receives the report.

#### BACKGROUND:

This agenda report provides an update regarding the redistricting process in anticipation of the release of the 2020 U.S. Census data. Specifically, this report provides an overview of redistricting, information about the need and selection of a consultant, redistricting laws and principles, timeline, and next steps.

#### Redistricting Overview

Redistricting is the process of adjusting City Council voting districts so that each district has substantially the same number of voting-aged residents. Cities with voting districts are required to update district maps following the release of the centennial US Census data.

El Cajon transitioned from an at-large to a by-district election process for Councilmembers with the passage of Measure S in November 2016. The Mayor remains elected at-large.

Following the passage of Measure S, the City retained National Demographic Corporation (NDC) to develop the voting district maps and facilitate public hearings. The City also retained the Institute for Local Government to assist with community outreach.

To involve the community in the map's development, the City hosted four public workshops. During the workshops, 125 people participated and the City received 160 maps or map drawings. In June 2017, the City Council approved the current District Election Map. It is important to note that the map was developed using the 2010 US Census data with 2017 demographic estimates.

The transition to City Council districts means that the City must evaluate and potentially adjust its voting districts based on the 2020 US Census. The US Census Bureau plans to release the 2020 Census data on **September 30, 2021**. Ordinarily, this data would be available to cities in March, but due to the pandemic, this date has been delayed several times. To comply with the Voting Rights Act, the City must approve a District Map no later than 205 days ahead of the November 8, 2022, General Election, or **April 17, 2022**.

#### Redistricting Consultant

The City can take a few steps ahead of the September census release to help with the compacted timeline. For instance, the City can begin outreach and education about the redistricting process as well as host pre-draft map hearings before the census data is received.

The City began an extensive search for demographer vendors in February 2021 and has since received six quotes. Of the quotes received, NDC was the lowest responsive qualified bidder. The City is in the process of executing an agreement with NDC. The agreement will include in-person public hearing facilitation, demographer or line drawing services, and a public online mapping tool.

The quote provides prices for two scenarios: 1) if the district populations are still balanced and no redistricting work is required by law; or, 2) if full redistricting services are needed. The cost for the first scenario is \$4,500, and the cost for the full redistricting process is \$51,000. It is important to note that even if the districts remain balanced, the City Council can always choose to proceed with the full redistricting process.

#### Redistricting Laws and Principles

There are numerous federal, state, and local redistricting laws with which cities must comply. The City's consultant will address these laws in future presentations, but a general overview is provided here.

The federal Voting Rights Act prohibits "gerrymandering" based on race. "Gerrymandering" is the process of manipulating district boundaries in order to favor one party or class. The Act also allows district maps to be legally challenged by a protected class if the district racially deludes voters. Federal law also requires districts to have substantially equal populations which courts have defined as 10 percent or less deviation between the lowest and highest voting populations.

The courts have also upheld several redistricting principles. For instance, election district maps must keep districts compact, contiguous, defined by visible (natural and man-made) boundaries, and include communities of interests—or groups with similarities other than race. These principles will be discussed further during the redistricting process by the consultant.

Most recently, the California legislature passed AB 849 known as the "Fair and Inclusive Redistrict for Municipalities and Political Subdivisions (FAIR MAPS) Act in 2019", and AB 1276 in 2020. AB 1276 provided cleanup language and clarifications of the FAIR MAPS Act. The FAIR MAPS Act requires cities to take additional steps to increase public engagement in the redistricting process. It increases the number of required public hearings to four, provides for translated materials and live translation services when requested in advance, mandates a redistricting website, and establishes noticing, record keeping, and hearing specifications.

#### Redistricting Timeline

The expected project timeline is:

- May 2021: Finalize execution of agreement with demographer;
- May September 2021: Begin community outreach and hold pre-draft map hearings;
- October 2021 January 2022: Census data received on September 30. Prepare draft maps and hold post-draft map hearings;
- January April 2022: Approve and adopt election district map and Implement new districts

Once an agreement is fully executed with NDC, staff will begin developing an outreach plan, determine the public hearing dates, and create a redistricting website with multi-lingual resources. Staff anticipates launching the public outreach component once an outreach plan has been formalized in conjunction with the public hearing schedule.

#### FISCAL IMPACT:

The redistricting agreement is anticipated to cost between \$4,500 and \$51,000.

SUBJECT: LEGISLATIVE UPDATE

#### SB 5 (Atkins - D) Housing Bond.

Expresses the intent of the Legislature to authorize the issuance of a bond, of an unspecified amount, to fund housing-related programs. (Status: Senate Housing Committee)

#### SB 6 (Caballero - D) Local Planning. Housing in Commercial Zones.

Would create the Neighborhood Homes Act, which establishes a housing development project as an authorized use on a neighborhood lot, defined as a lot zoned for office or retail commercial that is not adjacent to an industrial use. Duplicate bill to AB 115. Opposed by LCC. (Status: Suspense File/Hearing Pending)

#### **SB 9** (Atkins - D) Housing Development Approvals. Duplexes and Lot Splits.

Would require a local government to ministerially approve a housing development containing two residential units in single-family zones, and would require local governments to ministerially approve urban lot split. LCC opposed. (Status: Suspense file/Hearing pending).

#### AB 71 (Rivas, Luz - D) Homelessness Funding Bring California Home Act.

Would generate \$2.4 billion of state funding for long-term solutions to homelessness. These funds would go to local governments to invest in housing solutions that take into account a community's unique needs, whether urban or rural. The measure does so by conforming to federal tax law to close corporate tax loopholes and restoring historic corporate tax rates on corporations with \$5 million or more in profits. (Status: Suspense file).

## <u>ACA 1</u> (Aguiar-Curry) Local Government Financing. Affordable Housing and Public Infrastructure. Voter Approval.

Would create an additional exception to the 1 percent limit that would authorize a city, county, city and county, or special district to levy an ad valorem tax to service bonded indebtedness incurred to fund the construction, reconstruction, rehabilitation, or replacement of public infrastructure, affordable housing, or permanent supportive housing, or the acquisition or lease of real property for those purposes, if the proposition proposing that tax is approved by 55 percent of the voters of the city, county, or city and county. (Status: Local Gov't Comm.).

<u>AB 329</u> (**Bonta-D**) requires bail to be set at \$0 for all offenses, except serious or violent felonies, violations of specified protective orders, spousal battery, sex offenses, and DUI. (Status: Approp. Comm./Hearings canceled by author).

- <u>AB 331</u> (**Jones-Sawyer-D**) extends the current July 1, 2021 sunset for organized retail theft punishments indefinitely. (Status: Suspense file).
- <u>AB 333</u> (Kamlager-D) proposes to remove burglary, looting, felony vandalism, and identify fraud from crimes that define a pattern of criminal gang activity. (Status: Committee on Public Safety). (Status: Failed in Assembly).
- <u>AB 48</u> (Gonzalez-D) Prohibits use of kinetic energy projectiles, nor CN or CS gas to disperse as assembly, protest, or demonstration. (Status: Suspense file).
- SB 358 (Jones R) This bill would prohibit a person from entering the curtilage of a residential dwelling, as defined, with the intent to commit theft of a package shipped through the mail or delivered by a public or private carrier. The bill would make a violation of that prohibition punishable as a misdemeanor by imprisonment in a county jail for a term not exceeding one year. For a 3rd or subsequent violation within a 36-month period, the bill would make the crime punishable as a misdemeanor by imprisonment in a county jail for a term not exceeding one year or as a felony by imprisonment in a county jail for 16 months, or 2 or 3 years. By creating a new crime, the bill would impose a state-mandated local program. (Status: Suspense file/Hearing scheduled).
- <u>AB 1500/SB 45</u> (Garcia/Mullin and Portantino D) Wildfire Prevention, Safe Drinking Water, Drought Preparation, and Flood Protection Bond Act of 2022. Competing bills that will need voter approval. The measures would call for the issuance of over \$7B in bonds to fund various programs sought to address issues relating to the title of the measure. A state appointed committee would determine which projects would receive funding based on the project's potential for accomplishing the measure's objectives. (Status: Committee on Appr).
- <u>AB 418</u> (Valladares **D**) Creates a grant program for cities and counties of up to \$300,000 per year to provide "power resiliency" in the event of a forced power outage by a utility company due to environmental conditions. (Status: Suspend file)
- <u>AB 339 (Lee D) –</u> Requires City Councils, until 12/23, to provide telephonic and internet based options for public comment opportunities; develop a system to process requests for translation and interpretation services for public meetings; and require translation of agenda documents into more languages than what is currently required in law. Opposed by LCC. (Status: Committee on Appr.)
- <u>SB 284 (Stern D) -</u> This measure would expand the PTSD presumption for workers' compensation to classifications previously excluded. (Status: Suspend file/Hearing pending).
- <u>AB 845 (Rodriguez D)</u> This measure would allow an individual to retire with a disability pension as a result of a COVID-19 illness. Opposed by LCC. (Status: Passed by Assembly. In Senate).

- SB 8 (Skinner D) This measure would extend the sunset date for the Housing Crisis Act of 2019 from 2025 to 2030. The Housing Crisis Act declared a statewide housing crisis and froze nearly all development-related fees once a developer submits a "preliminary" application, including essential project specific fees. LCC opposed. (Status: Third reading Senate floor).
- <u>SB 15 (Portantino D) -</u> This measure, upon appropriation by the Legislature in the annual Budget Act or other statute, would require the Department of Housing and Community Development (HCD) to administer a program to provide incentives in the form of grants allocated to local governments that rezone idle sites used for a big box retailer or a commercial shopping center to instead allow the development of workforce housing. LCC support. (Status: Suspense file/Hearing pending).
- <u>AB 989 (Gabriel D) This measure would require HCD</u> to establish a housing appeals committee and would establish procedures by which an applicant for a conditional use permit or other discretionary approval for a housing development project, could appeal to that committee the decision of a city or county to either deny the application or approve the application with conditions in a manner rendering it infeasible for the development of the housing development project. LCC opposed. (Status: Suspense File).
- <u>AB 215 (Chiu D) This measure would require cities to have a mid-cycle housing</u> element consultation with HCD if housing production is below the regional average; require cities to amend their laws so as to attain HCD's "pro-housing designation" if housing production is substantially below the regional average; and allow the Attorney General to enforce violations of the Housing Crisis Act of 2019. LCC opposed. (Status: Suspense File).
- <u>AB 1401 (Friedman D)</u> This measure would prohibit a local government from imposing a minimum parking requirement, or enforcing a minimum parking requirement, on residential, commercial, or other development if the development is located on a parcel that is within one-half mile walking distance of public transit or located within a low-vehicle miles traveled area. LCC opposed. (Status: Committee of Approp).
- SB 621 (Eggman D) This measure would authorize a development proponent to submit an application for a development for the complete conversion of a structure with a certificate of occupancy as a motel or hotel into multifamily housing units to be subject to a streamlined, ministerial approval process, provided that development proponent reserves an unspecified percentage of the proposed housing units for lower income households, unless a local government has affordability requirements that exceed these requirements. LCC opposed. (Status: Committee on Gov't/First hearing was canceled by author).
- <u>AB 816 (Chiu D)</u> This measure would, on or before January 1, 2023, require each local agency to submit to HCD an actionable county-levelplan for meeting specific annual benchmarks, with the goal of reducing homelessness by 90% by 2029. Additionally, this

measure would allow the Inspector General to bring an action against the state, a local agency, or a city to compel compliance with the homelessness action plan. LCC opposed (Status: Suspense file).

- <u>AB 89 (Jones-Sawyer D)</u> This measure would increase the minimum qualifying age from 18 to 25 years of age, unless the individual has a bachelor's or advanced degree from an accredited college or university. LCC opposed. (Status: Assembly Third Reading).
- <u>SB 2 (Bradford D)</u> This measure outlines standards for peace officer decertification and eliminates qualified immunity for peace officers and custodial officers, or public entities employing peace officers or custodial officers sued under the Act. LCC opposed. (Status: Suspense file hearing pending).

#### **SB** 16 (Skinner – D) - This measure would:

- Make every incident involving use of force, sustained findings of unlawful arrests and unlawful searches, and incidents where a peace officer or custodial officer engaged in conduct involving prejudice or discrimination on the basis of specified protected classes to be subject to disclosure
- Require indefinite retention of all complaints and related reports or findings currently in the possession of a department or agency
- Require records subject to disclosure to be provided no later than 45 days from the date of a request for their disclosure, and would impose a civil fine not to exceed \$1,000 per day for each day beyond 30 days that records subject to disclosure are not disclosed. LCC opposed. (Status: Suspense file/hearing pending).
- <u>SB 556 (Dodd D)</u> Require local governments to make space available on street light poles, traffic signal poles, utility poles, and other public infrastructure to telecommunications providers; and Create ambiguity in the fees local governments can charge for access to their infrastructure. LCC opposes. (Status: Passed the Senate/In Assembly).
