Rolland Slade, representing the East County Homeless Task Force (ECHTF), spoke of the accomplishments of the program, and thanked the City Council for the many years of support.

Deputy Mayor Goble stated that this was the first time the force had shared their accomplishments in the City. Deputy Mayor Goble added that he would reconsider re-instating funds for ECHTF, which had been recently withdrawn.

Mayor Wells added that the City of El Cajon provides more services to the homeless population than any other city in the County of San Diego.

Consideration of re-instating funds for ECHTF will be added to a future City Council meeting.

#### **RECOMMENDATION:**

That the City Council:

- 1. Determines the list of qualified firms to provide professional services is exempt from the provisions of the California Environmental Quality Act in accordance with section 15378(b)(2) of the CEQA Guidelines; and
- 2. Adopts the next Resolution, in order, to award a pre-qualified list of firms for SOQ No. 007-24 On-Call Professional Services for a two-year term, with up to three additional one-year renewal options.

#### BACKGROUND:

The City has various upcoming projects which require professional services involving different disciplines. City staff determined that a list of pre-qualified firms shall be created for professional services, including disciplines such as general civic engineering, landscape architecture, construction management/inspection/labor compliance, land surveying, storm water municipal planning, and housing and real estate services. The approved list will be valid for a two-year period and may be extended by the City for up to three (3) additional one-year terms.

The intent is to establish a pre-qualification list of qualified firms to provide professional services on an "as-needed" basis when projects or services cannot be completed by City staff. Each project will require a contract with the selected firm for a term that is appropriate for the specific project. The contract may be extended for one (1) year renewal terms, not to exceed a contract total of five (5) years in length by the City Manager, where appropriate, so long as the initial contract term or any renewal term does not exceed \$75,000 to complete the assigned project. Pre-qualified firms may be selected on a rotating basis for individual tasks within each discipline under \$75,000 or proposals may be solicited from all pre-qualified firms. However, the City, at its sole discretion, reserves the right to select firms out of rotation when deemed to be in the best interest of the City. Proposals will be requested from all pre-qualified firms within each discipline for services in excess of \$75,000. The City reserves the right to advertise via competitive solicitation for any project it deems appropriate and pre-qualified firms have the opportunity to submit proposals.

A Statement of Qualifications (SOQ No. 007-24) was issued on April 13, 2023. The SOQ solicitation was obtained by 181 firms and 39 responses were received on May 18, 2023. The City received many excellent proposals, and selecting the top firms was a challenging and

lengthy task. Due to the extensive number of responses received, correspondence was sent to all bidders requesting an extension of proposals and pricing through September 15, 2023.

A three-person evaluation committee, comprised of City staff, independently reviewed each proposal. Proposals were evaluated for six critical areas utilizing an evaluation matrix and 100 point scale. The evaluation criteria included experience, project organization, technical competence/methodology, familiarity of state and federal procedures, and financial responsibility. The attached memorandum dated August 28, 2023 details the evaluation committee's findings.

Staff recommends the award of the following pre-qualified list for an initial two-year period, with three one-year renewal options:

WHEREAS, during the period that the eligibility list remains effective, each consultant selected for a project shall enter into a professional services agreement in the form as approved by the City Attorney, for such length of time, including extensions of renewal terms approved by the City Manager, but only necessary to complete the assigned project; and

WHEREAS, the City Council believes it to be in the best interests of the City to award the pre-qualified list of consultants, attached hereto as Exhibit "A," which list shall be approved and effective for an initial two-year period, but may be extend by the City Manager for up to three (3) one-year renewal terms, as recommended by City staff.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL CAJON AS FOLLOWS:

1. The above recitals are true and correct, and are the findings of the City Council.

2. The City Council hereby awards SOQ No. 007-24 for on-call professional services to the consultants listed in Exhibit "A," for an initial two-year period of prequalification status. #### SUBJECT: RECOMMENDATION TO AWARD – On-Call Professional Services, SOQ No. 007-24

On April 13, 2023, the City of El Cajon advertised a Request for Statements of Qualifications (SOQ) for On-Call Professional Services with the intent to establish a prequalification list of qualified firms. Over 39 firms submitted proposals by the May 18, 2023 deadline.

In accordance with 23 CFR 172, and the Federal Highway Administration (FHWA), local public agencies may engage consultants to perform architectural, engineering, and related services on federal-aided projects. Furthermore, local public agencies requesting federal/state funds to reimburse architectural and engineering consultants must follow the guidelines in Chapter 10, "Consultant Selection" of the California Department of Transportation (Caltrans) Local Assistance Procedures Manual and the Consultant Procurement Manual of the Caltrans Office of Policy Development and Quality Assurance. To fulfill these guidelines, the selection committee independently scored each consultant's proposal on the evaluation forms included in SOQ No. 007-24.

The proposal evaluation form is based on a weighted scale with criteria including: 1) Consultant's Ability & Experience, 2) Project Organization & Key Personnel, 3) Technical Competence/Proposed Method to Accomplish Work, 4) Familiarity of State & Federal Procedures, and 5) Financial Responsibility of Company/Firm, with a total possible of score of 300 points or (100 points per each evaluator).

The proposal submitted by Borelli and Associates, Incorporated was disqualified since they did not submit a complete proposal by the May 18, 2023 deadline.

The weighted scores from the selection committee resulted in the following rankings for each work discipline:

## **RECOMMENDATION:**

That the City Council approves the proposed revisions to the Principal Civil Engineer classification specification.

## BACKGROUND:

The City's current classification specification for Principal Civil Engineer was last updated in July 1996. Any changes made to the classification specification will not adversely impact any incumbents as the changes only include expansion of assignments and clean-up language. Based on staff's evaluation of the needs for the traffic engineering job function, and in line with comparable local municipal findings, staff recommends adding the Traffic Assignment as seen in the attachment. This modification allows the City to recruit a larger pool of applicants.

As mentioned, the proposed changes will not adversely impact any employees, and could potentially allow for internal growth by creating a promotional opportunity for City employees who may not currently have the Traffic Engineer license from the State of California, but otherwise have the Professional Engineer license, and are able to then pursue the Traffic Engineer license.

The mark-up version of the proposed classification specification revisions is attached. A copy of the revised classification specification was provided to the El Cajon Mid-Management Group (MMPEG), which represents this classification. MMPEG has reviewed and approved the proposed revisions as attached.

## CALIFORNIA ENVIRONMENTAL QUALITY ACT:

The proposed revisions to the Principal Civil Engineer classification specification are not a "Project" as defined under section 15378 of the State CEQA Guidelines because it is a governmental administrative activity which does not result in a physical change in the environment.

# PRINCIPAL CIVIL ENGINEER

## Classified Service

## **CLASSIFICATION DESCRIPTION**

**Function**: Under administrative direction, organize, supervise, and participate in the activities of one or more of the major functions in the engineering division and perform related work as required. Work assignments may overlap or reflect the duties of multiple tasks.

**<u>Class Characteristics</u>**: The class is the highest-level engineering position below the City Engineer and may act in the absence of the City Engineer if assigned. This lead/supervisory level job classification is responsible for managing highly visible and sensitive projects.

## **<u>Representative Duties</u>**: (All assignments)

- Confers with other City personnel, representatives of public and private agencies, and the public regarding engineering projects.
- Administers engineering division records and files related to the responsibilities of the respective major function.
- Participates in budget preparation.
- Prepares reports to the City Council and Planning Commission.
- Conducts meetings and participates on committees.
- Monitors environmental requirements on engineering projects.
- Performs and reviews difficult civil engineering work in connection with civil, traffic, or transportation engineering and other public works as necessary.
- Directs and administers all consultant engineering contracts.
- Prepares and administers grant funding applications for various programs.

#### In the Private Development/Storm Water assignment:

- Directs, reviews, and supervises the checking of tentative and final subdivision and parcel maps for compliance with local and State Subdivision Map Act regulations.
- Administers the review of improvement plans, drainage plans, and designs for compliance with City standards, specifications, conditions of approval, and environmental requirements.
- Prepares the Department of Public Works' comments on building permits, planning actions, tentative subdivision maps, annexations, and drainage/grading plans.
- Supervises the public counter operation, including maintenance of engineering drawings and recorded maps.
- Coordinates the preparation of lien contracts and other agreements.
- Oversees the project management and contract administration of drainage and storm water facilities projects.
- Oversees the management of the City's Storm Water Compliance Program in accordance with federal, state, and local laws.
- May represent the City Engineer at Planning Commission meetings.

## In the Design/Special Projects assignment:

- Directs, supervises, and performs professional engineering work in the planning, design, construction, and maintenance of streets, sanitary sewers, storm drains, traffic signals and traffic control devices, and other public works structures.
- May represent or assist the City Engineer at City Council hearings.
- Directs, supervises, and participates in the administration of City construction projects.
- Oversees the administration/monitoring of the City wastewater treatment and wastewater transportation agreements.
- Assists with the management and upkeep of City's infrastructure related master plans.
- Oversees the inspection and survey functions of the department.
- Oversees the wastewater billing program functions of the department.

Bargaining Group: MMPEG

• Directs, supervises and participates in maintaining the computerized street, sanitary sewer and drainage inventory for management, planning and maintenance of the public improvements.

#### In the Traffic assignment:

- Directs, supervises, and performs professional engineering work in the planning, design, construction, and maintenance of streets, traffic signals and traffic control devices, and other public works structures.
- Supervises and participates in traffic condition surveys, volume analyses, accident surveys and analyses, and parking surveys and analyses.
- Designs signal and channelization installations and prepares traffic signal timing schedules and diagrams.
- Determines the need and justification for traffic control devices, parking zones, Cityowned off-street parking, and one-way streets.
- Supervises the installation, maintenance, and operation of traffic control equipment, traffic signs, and street striping.
- Makes recommendations concerning traffic rules, regulations, and ordinances relating to vehicular flow, truck routes, and overload or oversized transportation permits.
- Administers the City traffic-related maintenance contracts, street light maintenance contracts, underground utility detection contracts, and underground utility districts contracts.

**Contacts and Relationships**: Contacts are varied and include engineers, contractors, property owners, utility and outside agency representatives, and developers. In many cases, the employee must exercise a high degree of persuasive ability and tact in gaining compliance with City requirements without resentment.

<u>Accountability</u>: The employee is accountable for efficient, accurate, and timely completion of work assigned. Employees must be informed of new standards and state legislation affecting local engineering or public works projects.

<u>Working Conditions</u>: Work is primarily in an office setting; however, fieldwork is occasionally required to inspect sites under consideration for development, locations of proposed improvement, or work under construction.

SUBJECT: Authorization to Apply for the FY2022-23 CalRecycle SB 1383 Grant.

# **RECOMMENDATION:**

That the City Council adopts the next Resolution, in order, to:

- 1. Authorize the City Manager or designee to apply for, and if awarded, accept the FY 2022-23 CalRecycle SB 1383 Local Assistance Grant Program
- 2. Authorize the City Manager or designee to execute any documents and agreements necessary to apply for and receive the grant funds.

## BACKGROUND:

Senate Bill (SB) 1383 set methane emissions reduction targets for California in a statewide effort to reduce emissions of short-lived climate pollutants. The Budget Act of 2022 authorizes CalRecycle to award grants to local jurisdictions to assist in implementing programs to meet these statutory requirements.

The SB 1383 Local Assistance Grant Program provides funding to assist local jurisdictions with meeting the following program requirements:

- Provide organics collection services to all residents and businesses
- Conduct education and outreach to the community
- Secure access to recycling and edible food recovery capacity
- Establish an edible food recovery program
- Procure recyclable and recovered organic products
- Monitor compliance and conduct enforcement

If funding is awarded, staff recommends utilizing the grant funds in the following areas related to organic waste:

- Collection,
- Education and Outreach,
- Edible Food Recovery,
- Capacity Planning,
- Procurement Requirements (Using Recycled Organic Products compost, mulch, electricity, and/or renewable gas and Recycled Paper and Paper Products),
- Record Keeping,
- Enforcement and Inspection, and
- Program Evaluation/Gap Analysis.

In order to apply and receive the grant funds, staff recommends that the City Council adopts a resolution that authorizes the City Manager or designee to apply for the FY2022-23 CalRecycle SB 1383 Grant.

Further, if the SB 1383 Grant is awarded, the resolution should also authorize the City Manager to accept the award and execute such agreements and other documents necessary to receive the funds.

CALIFORNIA ENVIRONMENTAL QUALITY ACT:

Authorization to apply for a CalRecycle grant does not constitute a "project" under the California Environmental Quality Act (CEQA) as the activity will have no significant effect on the environment and is a continuing administrative activity. It therefore qualifies for an exemption from CEQA in accordance with Sections 15061(b)(3) and 15378(b)(2).

FISCAL IMPACT:

None. No matching funds are required for this grant.

## RESOLUTION NO. -23

#### RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL CAJON AUTHORIZING APPLICATION FOR CALRECYCLE METHANE EMISSIONS REDUCTION OF SHORT-LIVED CLIMATE POLLUTANTS PAYMENT PROGRAM FUNDS, ACCEPTING ANY AWARD, AND AUTHORIZING CERTAIN ACTIONS RELATED THERETO

WHEREAS, Public Resources Code sections 14581, 42023.1(g) and 48000 et seq., provides that the Department of Resources Recycling and Recovery ("CalRecycle") establishes various programs to award grants to qualifying jurisdictions in furtherance of its mission; and

WHEREAS, one such program allows CalRecycle to award funds ("Program Funds") through grants specifically to recipients developing eligible projects to reduce methane emissions of short-lived climate pollutants ("Methane Emissions Reduction") in an effort to meet statewide targets to reduce such emissions; and

WHEREAS, if awarded Program Funds, City staff recommends that the Fiscal Year 2022-23 funding be used to: provide organics collection; conduct education and outreach to the community; secure access to edible food recovery; provide capacity planning; procure recyclable and recovered organic products; establish an edible food recovery program; keep records; provide enforcement and inspection; and provide program evaluation and gap analysis; and

WHEREAS, the City Council finds that it is in the City's best interest to authorize the City Manager to apply for Program Funds and, if awarded to the City, (1) execute such documents and agreements necessary to accept the Program Funds and (2) approve such expenditure of the Program Funds consistent with such local projects.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of El Cajon as follows:

1. The City Manager, or such person designated by the City Manager, is authorized to apply for CalRecycle Methane Emissions Reduction Program Funds.

2. The City Council hereby authorizes the City Manager (a) to accept such CalRecycle Funds awarded, if any (b) to execute any agreement, and amendments thereto, and such other documents necessary to apply, accept, and expend the funds, all in such form approved by the City Manager, and (c) to apply, accept, and expend such Program Funds for Methane Emissions Reduction purposes in the City.

3. The City Council hereby commits to using the funds for Methane Emissions Reduction.

# **RECOMMENDATION:**

That the City Council:

- 1. Authorizes the City Manager to execute agreements and related documentation with the new owner, KB Home Coastal Inc.;
- 2. Authorizes the City Clerk to accept bonds from KB Home Coastal Inc., which will be released after completion of improvements;
- 3. Authorizes the City Manager to terminate agreements and related documentation with the original owner, City Ventures Homebuilding, LLC; and
- 4. Authorizes the City Clerk to release bonds to City Ventures Homebuilding, LLC. after bonds from KB Home Coastal Inc. are secured.

## BACKGROUND:

On July 13, 2021, the City Council approved Tentative Subdivision Map No. 2021-0005 for a condominium subdivision comprising 116 residential townhomes by Resolution No. 060-21. On December 13, 2022, the City Council approved the Final Map, Subdivision Agreement, and bonds with the original owner, City Ventures Homebuilding, LLC ("City Ventures").

As of June 2023, KB Home Coastal Inc. ("KB Home") became the new owner of the project and desires to enter into a new successor subdivision agreement (the "KB Subdivision") and provide its own bonds to guarantee completion of all outstanding public and private improvements, replacing the sureties provided by City Ventures, which will then be released to the original developer.

As a result, City Ventures has requested to terminate the existing Subdivision Agreements upon KB Home guaranteeing the completion of all outstanding public and private improvements.

## CALIFORNIA ENVIRONMENTAL QUALITY ACT:

Approval of the Subdivision Agreement with KB Home Coastal and termination of the Subdivision Agreement with City Ventures is statutorily exempt under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines section 15268(b)(3).

FISCAL IMPACT:

There is no fiscal impact. The property owner has paid all fees.

#### SUBDIVISION AGREEMENT (Public Improvements) (300 El Cajon Boulevard)

THIS AGREEMENT entered into by and between the CITY OF EL CAJON, a California charter city and municipal corporation, hereinafter referred to as "City", and KB HOME COASTAL INC., a California corporation, hereinafter referred to as "Developer"; and

WHEREAS, Developer's predecessor in interest, City Ventures Homebuilding, LLC (the "Original Developer"), pursuant to the provisions of the Subdivision Map Act of the State of California and Title 16 of the El Cajon Municipal Code, entered into that certain Subdivision Agreement with the City of El Cajon dated January 17, 2023 (the "Subdivision Agreement") prior to the filing of Tentative Subdivision Map 2021-0005 ("TSM 2021-0005") which creates an obligation on the part of the Original Developer to complete certain public improvements as shown on the official plans, specifications and detailed drawings on file with the City Engineer of City (the "Improvements"), following the filing of the final subdivision map; and

WHEREAS, Developer has acquired all right, title and interest in and to TSM 2021-0005, and the property that is the subject of TSM 2021-0005, from the Original Developer, or its successor, or successors, in interest; and

# WHEREAS, the City Engineer has estimated the cost of said Improvements to be the sum of <u>THREE HUNDRED FIFTY-TWO THOUSAND FOUR HUNDRED DOLLARS AND NO</u> <u>CENTS (\$352,400.00</u>); and

WHEREAS, the Original Developer has posted a bond or other form of surety (the "Improvement Security") by a surety company admitted in California and acceptable to City (the "Surety Insurer"); and

WHEREAS, it is necessary that Developer, having acquired all or part of TSM 2021-0005, and all or part of the property that is the subject of TSM 2021-0005, agrees to complete the Improvements and enter in this Agreement, which replaces the Subdivision Agreement, and to replace the Improvement Security provided by the Original Developer and its Surety Insurer with an Improvement Security of its own, and by a surety company of its own choosing.

NOW, THEREFORE, IT IS AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

1. That in consideration of the release of the Original Developer from its obligations under the Subdivision Agreement, and the release of the Surety Insurer providing the Improvement Security for the benefit of the Original Developer, all arising out of the approval of said TSM 2021-0005 prior to the completion of the Improvements for said project, Developer hereby covenants and agrees to install and construct the said Improvements in accordance with the official plans, and that said Improvements shall be completed within two (2) years from the filing of the final subdivision map.

2. Should Developer fail to complete said Improvements within the time set forth above, City, at its option, has the right to enter onto the property to complete said Improvements. Should the City exercise such option, it shall be at the expense of Developer, or the City may, in the alternative, hold Developer and the Surety Insurer liable for damages.

3. Developer agrees to furnish and City agrees to release the Developer's Improvement Security in accordance with Title 16 of the El Cajon Municipal Code to secure warranty, faithful performance, and payment of labor and materials for said construction and installation. Any surety bonds shall be issued by corporate sureties admitted to do business in California and approved by the City Attorney. The form of said bonds shall be substantially as set forth in sections 66499.1 and 66499.2 of the Government Code of the State of California. Upon the receipt of an approved Improvement Security from Developer, in substitution of the Original Developer's Improvement Security, the Original Developer's Improvement Security shall be released by the City and shall be of no further force or effect.

4. Developer further agrees to furnish the following surety bonds or cash deposits, if applicable to the project (the "Additional Securities"). Any such bonds shall be issued by corporate sureties authorized to do business in California and approved by the City Attorney:

- a. <u>\$ 4,000.00</u> for Lot Staking
- b. <u>\$304,750.00</u> for installation of Underground Utilities
- c. <u>\$</u>-0- for any deposits or bonds identified in the Resolution approving this project not otherwise in this Agreement.

Upon acceptance of the Additional Securities from the Developer in substitution of the Additional Securities from the Original Developer, the City shall release such Additional Securities provided by the Original Developer, to the Original Developer or (in the case of any cash deposit) to such other person as directed by (1) the Original Developer, (2) any duly appointed and acting receiver, or (3) order of a court of competent jurisdiction.

5. The City or any officer or employee thereof shall not be liable for any injury to persons or property occasioned by reason of the acts or omissions of Developer, its agents or employees in the performance of this Agreement. Developer further agrees to protect and hold harmless City, its elected and appointed officials, officers and employees, from any and all claims, demands, causes of action, liability or loss of any sort because of, or arising out of, acts or omissions of Developer, its agents or employees, in the performance of this Agreement, including claims, demands, causes of action, liability or loss because of, or arising out of, the design or construction of the Improvements, provided, however, that the approved Improvement Security shall not be required to cover the provisions of this paragraph. Said indemnification and agreement to hold harmless shall extend to injuries to persons and damages or taking of property resulting from the design or construction of said subdivision and the Improvements as provided herein, and to adjacent property owners as a consequence of and/or the diversion of waters from the design, construction or maintenance of drainage systems, streets and other improvements. Acceptance by the City of the Improvements shall not constitute an assumption by the City of any responsibility

for such damage or taking.

City shall not be an insurer or surety for the design or construction of the subdivision pursuant to the approved improvement plans, nor shall any officer or employee thereof be liable or responsible for any accident, loss or damage happening or occurring during the construction of the work or Improvements as specified in this Agreement, except as it may be shown that said officers or employees specifically directed that said work or improvement be accomplished in a manner contrary to the wishes and desires of Developer, and Developer has filed a written objection with the City Engineer prior to commencing said work or improvement.

Provisions of this section shall remain in full force and effect for ten (10) years following substantial completion by the Developer of the Improvements.

6. Developer agrees to file with the City Clerk, at the time this executed agreement is submitted, a certificate of insurance by a company approved by the City Attorney in conformance with City Council policy.

#### SUBDIVISION AGREEMENT (Private Improvements) (300 El Cajon Boulevard)

THIS AGREEMENT entered into by and between the CITY OF EL CAJON, a California charter city and municipal corporation, hereinafter referred to as "City", and KB HOME COASTAL INC., a California corporation, hereinafter referred to as "Developer"; and

WHEREAS, Developer's predecessor in interest, City Ventures Homebuilding, LLC (the "Original Developer"), pursuant to the provisions of the Subdivision Map Act of the State of California and Title 16 of the El Cajon Municipal Code, entered into that certain Subdivision Agreement with the City of El Cajon dated January 17, 2023 (the "Subdivision Agreement") prior to the filing of Tentative Subdivision Map 2021-0005 ("TSM 2021-0005") which creates an obligation on the part of the Original Developer to complete certain private improvements as shown on the official plans, specifications and detailed drawings on file with the City Engineer of City (the "Improvements"), following the filing of the final subdivision map; and

WHEREAS, Developer has acquired all right, title and interest in and to TSM 2021-0005, and the property that is the subject of TSM 2021-0005, from the Original Developer, or its successor, or successors, in interest; and

WHEREAS, the conditions of TSM 2021-0005 also require the Principal to complete the Improvements prior to map approval, but further provides that if the Principal will build the residential units contemplated by TSM 2021-0005 in phases the Principal can also obtain map approval prior to completion of the Improvements if it secures the construction of the Improvements by furnishing a bond providing for the faithful performance in completing the Improvements, with an acceptable guarantee of completion of the Improvements; and

# WHEREAS, the City Engineer has estimated the cost of said Improvements to be the sum of <u>ONE MILLION FOUR HUNDRED SEVENTEEN THOUSAND NINE HUNDRED</u> DOLLARS AND NO CENTS (\$1,417,900.00); and

WHEREAS, the Original Developer has posted a bond or other form of surety (the "Improvement Security") by a surety company admitted in California and acceptable to City (the "Surety Insurer"); and

WHEREAS, it is necessary that Developer, having acquired all or part of TSM 2021-0005, and all or part of the property that is the subject of TSM 2021-0005, agrees to complete the Improvements and enter into this Agreement, which replaces the Subdivision Agreement, and to replace the Improvement Security provided by the Original Developer and its Surety Insurer with an Improvement Security of its own, and by a surety company of its own choosing.

NOW, THEREFORE, IT IS AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

1. That in consideration of the release of the Original Developer from its obligations under the Subdivision Agreement, and the release of the Surety Insurer providing the Improvement Security for the benefit of the Original Developer, all arising out of the approval of said TSM 2021-0005 prior to the completion of the Improvements for said project, Developer hereby covenants and agrees to install and construct the said Improvements in accordance with the official plans, and that said Improvements shall be completed within two (2) years from the date of the filing of the final subdivision map.

2. Should Developer fail to complete said Improvements within the time set forth above, City, at its option, has the right to enter onto the property to complete said Improvements. Should the City exercise such option, it shall be at the expense of Developer, or the City may, in the alternative, hold Developer and the Surety Insurer liable for damages.

3. Developer agrees to furnish and City agrees to release the Developer's Improvement Security in accordance with Title 16 of the El Cajon Municipal Code to secure warranty, faithful performance, and payment of labor and materials for said construction and installation. Any surety bonds shall be issued by corporate sureties admitted to do business in California and approved by the City Attorney. The form of said bonds shall be substantially as set forth in sections 66499.1 and 66499.2 of the Government Code of the State of California. Upon the receipt of an approved Improvement Security from Developer, in substitution of the Original Developer's Improvement Security, the Original Developer's Improvement Security shall be released by the City and shall be of no further force or effect.

4. Developer further agrees to furnish the following surety bonds or cash deposits, if applicable to the project (the "Additional Securities"). Any such bonds shall be issued by corporate sureties authorized to do business in California and approved by the City Attorney:

- a. \$ -0- for Lot Staking
- b. <u>\$ -0-</u> for installation of Underground Utilities
- c. <u>\$</u>-0- for any deposits or bonds identified in the Resolution approving this project not otherwise in this Agreement.

Upon acceptance of the Additional Securities from the Developer in substitution of the Additional Securities from the Original Developer, the City shall release such Additional Securities provided by the Original Developer, to the Original Developer or (in the case of any cash deposit) to such other person as directed by (1) the Original Developer, (2) any duly appointed and acting receiver, or (3) order of a court of competent jurisdiction.

5. The City or any officer or employee thereof shall not be liable for any injury to persons or property occasioned by reason of the acts or omissions of Developer, its agents or employees in the performance of this Agreement. Developer further agrees to protect and hold

harmless City, its elected and appointed officials, officers and employees, from any and all claims, demands, causes of action, liability or loss of any sort because of, or arising out of, acts or omissions of Developer, its agents or employees, in the performance of this Agreement, including claims, demands, causes of action, liability or loss because of, or arising out of, the design or construction of the Improvements, provided, however, that the approved Improvement Security shall not be required to cover the provisions of this paragraph. Said indemnification and agreement to hold harmless shall extend to injuries to persons and damages or taking of property resulting from the design or construction of said subdivision and the Improvements as provided herein, and to adjacent property owners as a consequence of and/or the diversion of waters from the design, construction or maintenance of drainage systems, streets and other improvements. Acceptance by the City of the Improvements shall not constitute an assumption by the City of any responsibility for such damage or taking.

City shall not be an insurer or surety for the design or construction of the subdivision pursuant to the approved improvement plans, nor shall any officer or employee thereof be liable or responsible for any accident, loss or damage happening or occurring during the construction of the work or Improvements as specified in this Agreement, except as it may be shown that said officers or employees specifically directed that said work or improvement be accomplished in a manner contrary to the wishes and desires of Developer, and Developer has filed a written objection with the City Engineer prior to commencing said work or improvement.

Provisions of this section shall remain in full force and effect for ten (10) years following substantial completion by the Developer of the Improvements.

6. Developer agrees to file with the City Clerk, at the time this executed agreement is submitted, a certificate of insurance by a company approved by the City Attorney in conformance with City Council policy.

Staff recommends the City Council determines that the project is categorically exempt in accordance with CEQA Guidelines section 15301 and adopts resolutions to (1) approve the plans and specifications for the project, and (2) award the bid to the lowest responsive, responsible bidder, TC Construction Company, Inc., in the amount of \$548,375. The summary of bids is attached, and complete proposals are on file in the Purchasing Division.

# BACKGROUND:

On July 23, 2019, the City Council authorized the award of the Street Striping & Removal Services bid in the not-to-exceed amount of \$126,611 for the initial term and \$395,363.67 for subsequent four-year renewal costs. On August 20, 2019, the City entered into a contract with Statewide Stripes, Inc.

During the course of the contract, the California Department of Transportation revised specifications for lane dividing striping from 4" wide striping to 6" wide striping, resulting in a higher cost per linear foot. Moreover, the Consumer Price Index has continued to rise since the onset of the contract, contributing to escalating costs. City staff is requesting an increase to the final renewal term, commencing September 15, 2023, in the amount of \$95,236.33 for a total annual not-to-exceed amount of \$100,000.

# CALIFORNIA ENVIRONMENTAL QUALITY ACT:

The proposed Street Striping and Removal Services project is exempt from the provisions of CEQA in accordance with section 15301(c) because it involves the maintenance and repair of existing public streets.

# FISCAL IMPACT:

Approval of the \$95,236.33 increase will supplement the renewal contract, for a total not-to-exceed amount of \$100,000. Sufficient funds are available in Fiscal Year 2023-24 Annual Budget – Public Works Traffic Maintenance-Repairs & Maintenance (101521).

#### RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL CAJON APPROVING A CONTRACT AMENDMENT AND AUTHORIZING ADDITIONAL COMPENSATION FOR STREET STRIPING AND REMOVAL SERVICES

WHEREAS, on July 23, 2019, the City Council authorized the award of Bid 010-20 for Street Striping and Removal Services (the "Project") to Statewide Stripes, Inc. (the "Contractor"), in the not-to-exceed amount of \$126,611.00 for the initial term of September 15, 2019 through September 14, 2020, with four optional one-year renewal periods in the not-to-exceed amount of \$395,363.67 for subsequent four-year renewal costs (the "Contract"); and

WHEREAS, during the course of the Contract, the California Department of Transportation unexpectedly revised specifications for lane-dividing striping from 4" wide striping to 6" wide striping, resulting in a higher cost per linear foot; further, the Consumer Price Index has continued to aggressively rise since the onset of the Contract, both of which resulted in an unforeseeable escalation of costs of supplies to the Contractor in performing work on the Project during any renewal terms to extend the Contract; and

WHEREAS, City staff has requested an increase of \$95,236.33 in compensation for the final renewal period of September 15, 2023 to September 14, 2024, for a total annual not-to-exceed amount of \$100,000, in order to renew the Contract and address these unforeseen increases in costs; and

WHEREAS, sufficient funds are available in Fiscal Year 2023-24 Annual Budget – Public Works Traffic Maintenance-Repairs & Maintenance; and

WHEREAS, the proposed increase would result in a total not-to-exceed compensation amount of \$617,211.00 for the aggregate cost of the Contract; and

WHEREAS, the City has previously determined that the Project is exempt from the provisions of California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines section 15301(c), which includes the maintenance and repair of existing public streets.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL CAJON AS FOLLOWS:

1. The above recitals are true and correct, and are the findings of the City Council.

2. The City Council hereby approves an amendment of the Contract to extend the term through September 14, 2024, and authorizes additional compensation in the not-to-exceed amount of \$95,236.33 for the Project, for a total not-to-exceed compensation amount of \$617,211.00.

3. The City Council hereby authorizes the City Manager, or such person as is designated by the City Manager, to execute an amendment to the Contract, with any such changes as may be necessary and approved by the City Manager.

#### **RECOMMENDATION:**

That the City Council adopts the next Resolution, in order, to:

- 1. Amend the scope of work and increase the compensation and working days for the Public Works Contract with Whillock Contracting, Inc. (WCI), for the restoration project in the not-to-exceed amount of \$300,000; and
- 2. Appropriate \$300,000 of Wastewater Enterprise Fund equity to increase the Broadway Creek Restoration Phase A (173586PWCP) project budget.

#### BACKGROUND:

On October 12, 2021, the City Council awarded the contract for Broadway Creek Restoration Phase A to the lowest responsive, responsible bidder, WCI, in the amount of \$2,755,479.24.

On December 13, 2022, the City Council adopted a resolution to amend the scope of work and increase the compensation (in a not-to-exceed \$592,958.99) and working days for the Public Works Contract. Additionally, City Council approved the appropriation of \$500,000 of Wastewater Enterprise Fund equity to increase the Broadway Creek Restoration Phase A (173586PWCP) project budget.

Work was suspended from October 2022 through February 2023 due to inclement weather which prevented managing construction operations resulting in significant damage to new improvements in the high-profile drainage channel. The new channel wall (concrete block mats) successfully conveyed high capacity storm water flows, however, topical improvements, such as, trees, vegetation, and topsoil eroded at various locations within the channel.

The proposed Wastewater allocation appropriation will be utilized to repair damaged areas in the channel and remove soil runoff inside the new concrete box culvert at Ballantyne Street.

The proposed Construction Change Order No. 2 includes:

- Move cobble to the sides along the east/west and north/south channel;
- Move cobble to the north side and place 12" minus rip rap and grout on the south side of the east/west channel;

- Move cobble to the east side and place 12" minus rip rap and grout on the west side of the north/south channel;
- Repair PVC pipe and regrade planters;
- Remove alluvial and export material at north cell; and
- Add an additional 40 working days to the project.

The requested increase of \$300,000 includes the additional scope of work specified above and a contingency amount for change order repair work of \$46,188.38 (\$253,188.38 for above-mentioned work and \$46,188.38 for change order contingency). The contingency amount authorizes staff to address matters immediately and avoid any further construction delays. The total cost of this increase exceeds 25% of the original contract value as established by City Council Policy B-4, thus requiring approval from the City Council.

### CALIFORNIA ENVIRONMENTAL QUALITY ACT:

In accordance with the California Environmental Quality Act (CEQA), an Initial Study and Mitigated Negative Declaration (MND) were prepared for this project. The mitigation measures, including a Habitat Mitigation and Monitoring Plan for the disturbance of habitat, regulatory permitting, archeological and Native American Monitoring, and a Noise Construction Management Plan, were included in a Mitigation, Monitoring & Reporting Program (MMRP) to ensure impacts are successfully mitigated. On May 11, 2021, the City Council adopted the MND by resolution.

### FISCAL IMPACT:

Approval of the \$300,000 will supplement the current contract, for a total not-to-exceed amount of \$3,647,738.23. Funds are available in Fiscal Year 2023-24 Annual Budget: Broadway Creek Restoration Phase A (173586PWCP) and contingent upon approval of additional funding.

The appropriation will increase Broadway Creek Restoration Phase A appropriations, and reduce the Wastewater Enterprise Fund equity, by \$300,000 in order to accommodate the change order described in this report.

WHEREAS, on December 13, 2022, the City Council adopted Resolution No. 115-22 to amend the Contract to expand the scope of work for the Project; add seventy-eight (78) additional working days; increase compensation in an amount not to exceed \$592,958.99 for the additional work; and appropriate \$500,000 of Wastewater Enterprise Fund equity to increase the Project budget; and

WHEREAS, work was suspended from October 2022 through February 2023 due to inclement weather, which prevented managing construction operations and resulted in significant damage to new improvements in the high-profile drainage channel; and

WHEREAS, due to the inclement weather, topical improvements, such as trees, vegetation and topsoil, eroded or were damaged at various locations within the channel (the "Storm Damage"); and

WHEREAS, the proposed Wastewater allocation appropriation will be utilized to repair damaged areas in the channel and remove soil runoff inside the new concrete box culvert at Ballantyne Street; and

WHEREAS, due to the Storm Damage, the City and the Contractor have negotiated the proposed Construction Change Order No. 2, which includes: (1) moving cobble to the sides along the east/west and north/south channel; (2) moving cobble to the north side and placing 12" minus rip rap and grout on the south side of the east/west channel; (3) moving cobble to the east side and placing 12' minus rip rap and grout on the west side of the north/south channel; (4) repairing PVC pipe and regrade planters; (5) removing alluvial and exporting material at north cell; and (6) adding forty (40) additional working days to the project; and

WHEREAS, staff has requested an increase of \$300,000.00, to include \$253,188.38 for the additional scope of work specified in (1)-(6), above, and \$46,188.38 for change order contingency, which would allow staff to immediately address unforeseen matters and avoid further construction delays; and

WHEREAS, the total cost of this increase exceeds twenty-five percent (25%) of the Contract value as established by City Council Policy B-4, thus requiring approval from the City Council; and

WHEREAS, approval of the \$300,000.00 increase in compensation will supplement the current Contract amount of \$3,347,738.23, for a total not-to-exceed aggregate amount of \$3,647,738.23, and funds are available in Fiscal Year 2023-24 Annual Budget: Broadway Creek Restoration Phase A, contingent upon approval of additional funding; and

WHEREAS, in accordance with the California Environmental Quality Act ("CEQA"), an Initial Study and Mitigated Negative Declaration ("MND") were previously prepared for the Project, and adopted by City Council on May 11, 2021, by Resolution No. 040-21; and

WHEREAS, the City Council believes it to be in the best interests of the City to amend the Contract to expand the scope of work, approve the additional not-to-exceed amount of \$300,000.00 for the additional work, and authorize additional working days.

#### SUBDIVISION AGREEMENT (Public Improvements) (1540 Mint Avenue)

THIS AGREEMENT entered into by and between the CITY OF EL CAJON, a California charter city and municipal corporation, hereinafter referred to as "City", and Delgesh Shahab, an individual, hereinafter referred to as "Developer"; and

WHEREAS, Developer, pursuant to the provisions of the Subdivision Map Act of the State of California and Title 16 of the El Cajon Municipal Code, contemplates the filing of Tentative Parcel Map 2021-0004 ("TPM 2021-0004") prior to the completion of certain public improvements as shown on the official plans, specifications and detailed drawings on file with the City Engineer of City (the "Improvements"); and

WHEREAS, the City Engineer has estimated the cost of said Improvements to be the sum of SIXTY SEVEN THOUSAND THREE HUNDRED THIRTY EIGHT DOLLARS AND NO CENTS (\$67,338.00); and

WHEREAS, Developer has or will post a bond or other form of surety (the "Improvement Security") by a surety company admitted in California and acceptable to the City (the "Surety Insurer").

NOW, THEREFORE, IT IS AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

1. That in consideration of the approval of said TPM 2021-0004 prior to the completion of the Improvements for said project, Developer hereby covenants and agrees to install and construct the said Improvements in accordance with the official plans, and that said Improvements shall be completed within three (3) years from the date of the recording of the subdivision map by the County Recorder of the County of San Diego.

2. Should Developer fail to complete said Improvements within the time set forth above, City, at its option, has the right to enter onto the property to complete said Improvements. Should the City exercise such option, it shall be at the expense of Developer, or the City may, in the alternative, hold Developer and the Surety Insurer liable for damages.

3. Developer agrees to furnish and City agrees to release the Improvement Security in accordance with Title 16 of the El Cajon Municipal Code to secure warranty, faithful performance, and payment of labor and materials for said construction and installation. Any surety bonds shall be issued by corporate sureties admitted to do business in California and approved by the City Attorney. The form of said bonds shall be substantially as set forth in Sections 66499.1 and 66499.2 of the Government Code of the State of California.

4. Developer further agrees to furnish the following surety bonds or cash deposits, if applicable to the project. Any such bonds shall be issued by corporate sureties authorized to do business in California and approved by the City Attorney:

- a. <u>\$ 3,200.00</u> for Lot Staking
- b. <u>\$ -0-</u> for installation of Underground Utilities
- c. <u>\$ -0-</u> for any deposits or bonds identified in the Resolution approving this project not otherwise in this Agreement.

5. The City or any officer or employee thereof shall not be liable for any injury to persons or property occasioned by reason of the acts or omissions of Developer, its agents or employees in the performance of this Agreement. Developer further agrees to protect and hold harmless City, its elected and appointed officials, officers and employees, from any and all claims, demands, causes of action, liability or loss of any sort because of, or arising out of, acts or omissions of Developer, its agents or employees, in the performance of this Agreement, including claims, demands, causes of action, liability or loss because of, or arising out of, the design or construction of the Improvements, provided, however, that the approved Improvement Security shall not be required to cover the provisions of this paragraph. Said indemnification and agreement to hold harmless shall extend to injuries to persons and damages or taking of property resulting from the design or construction of said subdivision and the Improvements as provided herein, and to adjacent property owners as a consequence of and/or the diversion of waters from the design, construction or maintenance of drainage systems, streets and other improvements. Acceptance by the City of the Improvements shall not constitute an assumption by the City of any responsibility for such damage or taking.

City shall not be an insurer or surety for the design or construction of the subdivision pursuant to the approved improvement plans, nor shall any officer or employee thereof be liable or responsible for any accident, loss or damage happening or occurring during the construction of the work or Improvements as specified in this Agreement, except as it may be shown that said officers or employees specifically directed that said work or improvement be accomplished in a manner contrary to the wishes and desires of Developer, and Developer has filed a written objection with the City Engineer prior to commencing said work or improvement.

Provisions of this section shall remain in full force and effect for ten (10) years following substantial completion by the Developer of the Improvements.

6. Developer agrees to file with the City Clerk, at the time this executed agreement is submitted, a certificate of insurance by a company approved by the City Attorney in conformance with City Council policy.

SUBJECT:	Proposed Veterans Memorial Location

#### **RECOMMENDATION:**

That the City Council identifies a location for a proposed Veterans Memorial.

#### BACKGROUND:

One of the priorities established by the City Council for the past two years has been to explore an improved upon Veterans Memorial. As part of that, staff has actively engaged the public and stakeholders to gather input on a new Veterans Memorial in El Cajon. The existing Veterans Memorial in front of The Magnolia no longer complements the venue as it did when it was installed in 2000, nor does it adequately honor El Cajon's Armed Forces members. In mid-2022, staff brought forward a status report on the project and the City Council. During that meeting, possible locations and the inclusion of the Space Force in the memorial design were discussed.

As part of the outreach effort, staff has conducted 29 interactions with the community and stakeholders, including veterans groups such as AMVETS, VFW, Marine Corps League Detachment, and Navy Fleet Reserve Association at the Veterans Memorial Hall. Also, over 200 surveys at community events were received with feedback. Staff also presented to the San Diego East County Chamber's VECA Group and engaged with American Legion Post 303, a crucial veterans service non-profit. The American Legion Post 303 suggested a preferred location for the memorial in front of the Public Safety Building at 100 Civic Center Way. They also recommended including the Merchant Marines and a First Responder memorial in the design. As a reminder, American Legion Post 303 manages the two existing veterans memorials in El Cajon and actively hosts veteran-related events.

Alternatively, the City of El Cajon Veterans Coalition, along with feedback from surveys, suggested other possible locations. The intent of this agenda item is to present three possible locations for consideration:

- 1. Prescott Promenade,
- 2. In front of the Public Safety Building (Police Station), and
- 3. Judson Park (at Park & Magnolia).

As part of the presentation, staff will present the pros and drawbacks of each site and seek City Council feedback on a location to further pursue. Once a location is identified, staff can begin to procure the services of a designer and begin to focus on cost estimates.

#### CALIFORNIA ENVIRONMENTAL QUALITY ACT:

The selection of a Veterans Memorial location is not subject to the California Environmental Quality Act (CEQA) because it is not a "project" as defined by CEQA that will result in a direct or indirect physical change in the environment.

FISCAL IMPACT:

Fiscal impact will be determined after further evaluation.

SUBJECT: All-Way Stop Sign Request on Windmill View Road at Woodglen Way

#### **RECOMMENDATION:**

That the City Council adopts the next Resolution, in order, to establish permanent all-way stop signs on Windmill View Road at the intersection of Woodglen Way in order to enhance pedestrian and traffic safety.

#### BACKGROUND:

Periodically, the Public Works Department receives requests to investigate the need for additional regulatory signs on City streets. Not all requests meet the criteria established by the Caltrans Highway Design Manual. Nearby residents have expressed concern about the lack of sight distance to view oncoming traffic when exiting the Woodglen Way cul-de-sac onto Windmill View Road.

#### **Existing Conditions**

Windmill View Road is a north-south "residential collector" street that extends from Valley Lake Drive to Hacienda Drive and has a posted speed limit of 30 miles per hour. A "Stop" sign on Woodglen Way controls this "T" intersection with no stop signs on Windmill View Road. Approximately 1,500 vehicles travel through this intersection daily.

The corner sight distance was measured to determine if a vehicle traveling from Woodglen Way has adequate sight distance to enter Windmill View Road safely. Based on the Caltrans Highway Design Manual, the minimum corner sight distance of 335 feet is desirable for a street with a posted speed limit of 30 miles per hour. The field investigation revealed that the available corner sight distance measured (177 feet) is less than the desirable requirement. City traffic records indicate that one (1) collision has occurred north of this intersection during the past five (5) years.

#### All-Way Stop Sign Analysis on Windmill View Road at Woodglen Way

The City of El Cajon follows the California Manual on Uniform Traffic Control Devices (CAMUTCD) guidelines. It uses a "point" system developed by the City of San Diego to evaluate the need to install all-way stop signs. Existing site conditions, traffic volumes, sight distance obstructions, school proximity, and accident history are criteria for determining the need for all-way stops. A minimum of 30 points out of 50 is typically required to install all-way stop signs. The results of the data collected at this intersection revealed that a total of 19 points were tallied at this location.

Using the point system guidelines, this intersection does not satisfy all the required all-way stop sign traffic volume and accident history warrants. However, the less-than-desirable minimum sight distance available to allow for the safer passage of vehicles and pedestrians crossing at this intersection is a more compelling justification for the installation of an all-way stop. Based on this safety concern, staff recommends that the all-way stop be considered by the City Council.

#### CALIFORNIA ENVIRONMENTAL QUALITY ACT:

The proposed all-way stop signs project to improve public safety is exempt from the provisions of the California Environmental Quality Act pursuant to CEQA Guidelines section 15301(c).

FISCAL IMPACT:

Approximately \$2,500 for the installation of all-way stop signs, stop ahead signs, and pavement legends. This cost is budgeted in the Fiscal Year 2023-24 Traffic Maintenance Annual Budget (101521).

#### RESOLUTION TO ESTABLISH ALL-WAY STOP SIGNS ON WINDMILL VIEW ROAD AT WOODGLEN WAY

WHEREAS, the City Council recognizes that the health, safety, and welfare of the residents of the City of El Cajon ("City") is vitally important, and that from time to time vehicular traffic control measures are necessary to protect pedestrian traffic along and across public roads; and

WHEREAS, Woodglen Way is a two-way cul-de-sac residential street with its outlet creating a "T" intersection with Windmill View Road, a north-south "residential collector" street having a posted speed limit of 30 miles per hour; and

WHEREAS, a "Stop" sign on Woodglen Way controls this intersection with no stop signs on Windmill View Road; and

WHEREAS, approximately 1,500 vehicles travel through this intersection on a daily basis, and due to the configuration of the intersection the corner sight distance to enter onto Windmill View Road is less than the minimum requirement of 335 feet desirable for a street with a posted speed limit of 30 miles per hour as set out in the Caltrans Highway Design Manual; and

WHEREAS, the California Manual on Uniform Traffic Control Devices uses a "point" system to evaluate existing site conditions, traffic volumes, site distance obstructions, proximity to schools, and accident history as criteria used in the determination of the need to install all-way stops; and

WHEREAS, results of the data collected at this intersection revealed that although the total of points does not meet the criteria for the installation of an all-way stop, the lessthan-desirable sight distance and the need to reduce the speed of vehicles traveling in excess of 30 miles per hour to allow the safe passage of pedestrians and vehicles crossing at the intersection supports a determination that all-way stop signs should be installed at the above-referenced location for the health, safety and welfare of the residents.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL CAJON AS FOLLOWS:

1. The foregoing recitals are true and correct and are the findings of the City Council.


2. The City Council further finds that this project is exempt from environmental review under California Environmental Quality Act Guideline 15301(c) (Class 1) as it is a minor alteration of an existing public street involving negligible or no expansion of an existing use.

3. Due to the less-than-desirable sight distance for vehicles entering Windmill View Road from Woodglen Way, the intersection of Windmill View Road (north-south) and Woodglen Way (east-west cul-de-sac), shall be designated as an "all-way stop."

4. The Director of Public Works is hereby directed to immediately cause the installation of appropriate signs to establish the intersection of Windmill View Road at Woodglen Way, as an "all-way stop," as soon as reasonably possible.




Woodglen Way at Windmill View Drive Viewing left (south)

Approach from south of intersection




### Windmill View Road at Woodglen Way

SECTION 1: That the establishment of speed limits on existing public streets is categorically exempt from the provisions of the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines section 15301(c).

SECTION 2: That the designations of "Washington Avenue, from El Cajon Boulevard to First Street," listed in those sections of roads under the heading of "Forty Miles Per Hour," and "Washington Avenue, from First Street to Granite Hills Drive," listed in those sections of roads under the heading of "Forty-five Miles Per Hour", in section 10.20.130 of Chapter 10.20 of the El Cajon Municipal Code, are hereby deleted.

SECTION 3: That the designation of "Washington Avenue from El Cajon Boulevard to Granite Hills Drive," is hereby added in alphabetical order to the list of those sections of roads under the heading of "Forty Miles Per Hour" in section 10.20.130 of Chapter 10.20 of the El Cajon Municipal Code.

SECTION 4: This ordinance shall be effective thirty days following its passage and adoption.

# Staff Report Engineering & Traffic Survey for Washington Avenue

#### **Background:**

The existing "Engineering and Traffic Surveys" have expired on Washington Avenue between El Cajon Boulevard and Granite Hills Drive. The California Vehicle Code, Section 40802, requires that an "Engineering and Traffic Survey" be conducted every five (5) years to enable the Police Department continued use of radar to legally enforce the speed limit. Sections 627 and 40802 of the CVC code grants local authorities the right to establish speed limits on streets within their jurisdiction. The "Engineering and Traffic Survey" is intended to serve as the basis for the establishment and enforcement of speed limits on City streets. Expired speed surveys are considered a "Speed Trap" per the CVC code and are not enforceable.


#### "Engineering and Traffic Survey" to establish the Speed Limit:

The latest (2014 rev. 7) edition of the California Manual on Uniform Traffic Control Devices (CAMUTCD) establishes the procedure on how to conduct "Engineering and Traffic Surveys". The survey includes the measurements of the prevailing speed of traffic on the roadway that includes a sample of a minimum of 50 vehicles in each direction. An analysis of vehicle accident history, a review of the road, adjacent land use characteristics, and conditions not readily apparent to the motorist are also considered.

The CAMUTCD guidelines allows the local authority to establish the posted speed limit to within nearest five (5) miles per hour increment of the 85<sup>th</sup> percentile speed. The 85<sup>th</sup> percentile speed is defined as that speed of traffic at or below which 85 percent of the traffic is free flowing. The guidelines allow a reduction to the lower 5 MPH increment of the 85<sup>th</sup> percentile speed for conditions not readily apparent to the motorist. A sample speed survey statistics graph is shown on the following page. It is important to note that posting an arbitrarily lowered speed limit would have a negative affect and would make the majority of vehicles traveling on the road speed violators and may compromise safety. Also, it is important to note the that the Police Department cannot legally enforce an arbitrarily lowered posted speed limit.

#### **Traffic Engineering Analysis:**

Surveys were conducted on Washington Avenue in accordance with the guidelines outlined in the CAMUTCD. Survey samples of at least 50 vehicles were collected for each direction of travel. The samples were collected during the off-peak hours between 9:00 AM to 11:00 AM and from 1:00 PM to 4:00 PM during April and May of this year.



Sample Speed Study

Research of all relevant records including collision data and average daily traffic volumes along Washington Avenue. The collision history for a period of one year (2022) was collected. With this data, the accident rate per one million vehicle miles of travel was calculated for Washington Avenue. The current California State average rate for a four-lane roadway similar to Washington Avenue is 2.04 accidents per million vehicle miles traveled. The data is summarized below in Table 1:


