#### RECOMMENDATION:

#### That the City Council:

- 1. Determines that the procurement of Health and Fitness Assessment services is exempt from the California Environmental Quality Act in accordance with state CEQA Guidelines section 15378(b)(5); and
- 2. Adopts the next Resolution, in order, to (a) award a contract to On Duty Health, LLC for Health and Fitness Assessment Services in the amount of \$137,449 for the initial one-year term, with four additional one-year renewal options, and (b) authorize the City Manager to execute the final contract with such changes as the City Manager and the City Attorney approve. The City of El Cajon's portion of award is \$88,655.

#### **BACKGROUND:**

The cities of El Cajon, La Mesa, and Lemon Grove would like to establish a multi-city agreement that provides annual comprehensive on-site health and fitness assessments with cancer screening for first responders. The services would be provided to the cities' fire departments, in addition to the City of El Cajon's Police Department. The agreement includes an option to renew for four optional one-year terms. Funds for the renewal terms will be in accordance with the approved budget for each fiscal year. Each participating agency is responsible for its own payment. It is anticipated that the three cities would all join in a single contract or, if desired, each city would enter into separate contracts all of which would contain the same terms and conditions.

The Fire Department submitted the attached memorandum dated October 11, 2023 with sole source justification to procure health and fitness assessment services from On Duty Health, LLC due to the extensive services provided, to include but not limited to, enhanced cancer screening, on-site phlebotomy services, and the ability to maintain data that tracks trends and patterns of staff regionally which assists in mitigating health risks and aids in determining the appropriate personal protective equipment to purchase. The request has been reviewed by the Purchasing Division and determined to be in the City's best interest.

As a result, this purchase is recommended as an exception to the City's competitive bidding requirement pursuant to ECMC section 3.20.010(C)(5), finding that: "The bidding procedures of this chapter may be waived, and an open market purchase pursuant to section 3.20.110 of this chapter may be authorized for all expenditures not involving a public project when the

commodity or service can be obtained from only one source." Staff recommends this purchase be made from On Duty Health, LLC.

#### CALIFORNIA ENVIRONMENTAL QUALITY ACT:

The proposed Health and Fitness Assessment Services is exempt from the California Environmental Quality Act (CEQA) because it is not a "project" pursuant to section 15378(b)(5) of the state CEQA Guidelines. The action is an administrative activity of government that will not result in a direct or indirect physical change in the environment.

#### FISCAL IMPACT:

The fiscal impact for the initial one-year term is \$88,655. Sufficient funds are available for this service in Fiscal Year 2023-24 Annual Budget: Police Department Insp-Medical & Psych Svs (101301) and Fire Supr-Medical & Psych Svs (101410). Subsequent 4-year costs are estimated to total \$401,219.84 for the City of El Cajon.

## RESOLUTION OF THE CITY OF EL CAJON APPROVING AND AUTHORIZING THE EXECUTION OF AN AGREEMENT FOR HEALTH AND FITNESS ASSESSMENT SERVICES WITH ON DUTY HEALTH, LLC

WHEREAS, the City of El Cajon (the "City"), the City of La Mesa, and the City of Lemon Grove (collectively, "Heartland" or "HFR") desire to enter into a combined, or separate but standard agreements, with the same vendor, to provide annual comprehensive on-site health and fitness assessments with cancer screening for first responders with Heartland (each, an "Agreement") for an initial one-year term, with the option to renew for four (4) additional one-year periods; and

WHEREAS, the services would be provided to HFR's fire departments and the City's police department, and each Heartland agency could execute their own form of the Agreement, or execute the same Agreement with the vendor, but in any event be responsible for its own costs and payments; and

WHEREAS, because of the extensive services provided and the commonality of interests, Heartland and City staff recommend entering into an Agreement with On Duty Health, LLC ("On Duty") for health and fitness assessment services to include, but not limited to, enhanced cancer screening, on-site phlebotomy services, and the ability to maintain data that tracks trends and patterns of staff regionally which assists in mitigating health risks and aids in determining the appropriate personal protective equipment to purchase; and

WHEREAS, this purchase is recommended as an exception to the City's competitive bidding requirement pursuant to El Cajon Municipal Code section 3.20.010 (C) (5), finding that: "The bidding procedures of this chapter may be waived, and an open market purchase pursuant to section 3.20.110 of this chapter may be authorized for all expenditures not involving a public project when the commodity or service can be obtained from only one source"; and

WHEREAS, the fiscal impact for the initial one-year term is the amount of \$88,655.00 as the City's share of the total annual cost, and sufficient funds are available in Fiscal Year 2023-24 Annual Budget; and

WHEREAS, the City's renewal costs for the optional four (4) one-year periods are estimated to total \$401,219.84, and funds will be available in accordance with the approved budget for each fiscal year; and

WHEREAS, the proposed Agreement is exempt from the California Environmental Quality Act ("CEQA") as it is not a "project" under section 15378(b)(5) of CEQA Guidelines, and the action involves an organizational or administrative activity of government that will not result in a direct or indirect physical change in the environment; and

WHEREAS, the City Council believes it to be in the City's best interest to approve the Agreement with On Duty, in the not-to-exceed total amount of \$88,655.00 for the initial one-year term, with four additional one-year renewal options estimated to cost the City an additional \$401,219.84.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL CAJON AS FOLLOWS:

Section 1. The above recitals are true and correct, and are the findings of the City Council.

Section 2. The City Council hereby authorizes the City Manager, or designee, to execute an agreement with On Duty Health, LLC ("On Duty"), for health and fitness services (the "Agreement") on behalf of the City of El Cajon, with such changes as may be approved by the City Manager, or designee, and to take all actions and to execute all documents, attachments to the Agreement, and other documents necessary or appropriate to carry out the terms of the Agreement. The Agreement may be jointly executed by the cities of La Mesa and Lemon Grove as clients of On Duty, or may be a separate contract between the City and On Duty, whatever the City Manager deems appropriate to obtain the services. The City Manager is further authorized to execute any amendments to the Agreement to extend the term of the Agreement on behalf of the City for not more than four (4) additional one-year periods.

SUBJECT: Annual Wellness Physical Program Sole Source Purchase Order Request

The Fire Department is submitting a request for multiple year contract and FY24 purchase order for specialized annual Physical/Fitness Assessments on behalf of the El'Cajon Fire and Police Departments, and the fire departments of the cities of La Mesa and Lemon Grove, with On Duty Health as our selected vendor. Although the El Cajon Police department has not participated in prior years, they have seen the value of this type of annual staff physical and secured funding in their FY24 budget to enhance their Wellness Program. These physicals, as defined by the National Fire Protection Association, include a medical history evaluation, hands-on physical exam, blood analysis, vision testing, audiometry testing, pulmonary function testing, treadmill stress test with 12 lead EKG, and cancer-screening elements. These physicals comply with NFPA 1582, NFPA 1583, and Wellness Fitness Initiative standards and also with the state mandated requirements for fire departments, with our Heartland Fire & Rescue (HFR) department-wide standards, and with the current Memorandum of Understanding Between City of El Cajon And El Cajon Professional Firefighters Local 4603 (Article 6 Section E). HFR has been scheduling these annual physicals since the inception of the HFR Wellness Program established by Council direction on September 11, 2018 under the Assistance to Firefighters Grant (AFG) at that time. The most important benefits of these physicals are: the early cancer detections, presentation of ongoing health trends over time and in general. After year one, the HFR Wellness Program was seen as such an overall benefit that it was extended and approved for funding annually in the Fire department's budget each year since.

The cost of the annual physicals with On Duty Health is \$90,000 (\$46,000 for PD and \$44,000 for Fire). We understand the normal purchasing process is to request a formal bid. However, on behalf of the El Cajon Fire and Police departments, we are requesting a sole source approval and for Council to waive the formal bid process per the Municipal Code section 3.20.010.C5. In summary, this section allows the city council to waive the bid process, for all expenditures not involving a public project when the city council determines that due to special circumstances it is in

the city's interest to waive the bidding requirement. The circumstances in this situation are the significant benefits in using On Duty Health: this vendor is a mobile operation, licensed to work in California, and has lower prices than their few competitors who responded to our internal request for quote. For the prior two years, this vendor has been used for our annual department physicals. Because On Duty Health is a mobile vendor, we have been able to: save resources (money and time) with minimal effect on our operations by eliminating the need to put apparatus out of service, affecting response times and availability, and ultimately saving on overtime costs.

We would like to request your approval based on several key factors. This vendor is able to meet our time constraints of performing annual physicals during the "off season" early calendar year months. The Fire Department has an established program with On Duty Health making FY24 the third year. Another benefit to staying with On Duty Health is they have the historical data of our staff's physicals, which is one of the most important factors in tracking and seeing trends over time. This vendor is also working with other Fire departments and districts in our region, which brings an added benefit of knowing and tracking regional health concerns amongst our staff.

Please accept this memo requesting approval of a multiple year contract, and sole source purchase order waiving the formal bid process due to special circumstances.

### AGREEMENT FOR HEALTH AND FITNESS ASSESSMENT SERVICES FOR THE CITIES OF EL CAJON, LA MESA AND LEMON GROVE

**THIS AGREEMENT** is made and entered into of the date set forth below, by and between the City of El Cajon, a California charter city and municipal corporation ("El Cajon"); the City of La Mesa, a California general law city and municipal corporation ("La Mesa"); the City of Lemon Grove, a California general law city and municipal corporation ("Lemon Grove"); (El Cajon, La Mesa, and Lemon Grove individually a "City" and collectively the "Cities") and On Duty Health, LLC, a Texas limited liability company (the "Consultant"), with reference to the following facts:

#### **RECITALS**

WHEREAS, the Cities desire to retain the Consultant to provide annual comprehensive onsite health and fitness assessments with cancer screening, on-site phlebotomy services, and maintenance of data that tracks trends and patterns of staff for the Cities' fire departments and El Cajon's police department (the "Services"); and

WHEREAS, the Cities have determined the Consultant has the expertise, experience, qualifications, and personnel necessary to provide the Services required by the Cities to the Cities' fire departments and El Cajon's police department (collectively the "Departments"); and

WHEREAS, the Cities, in performing governmental functions or in paying for the performance of governmental functions hereunder, shall continue to make that performance or those payments from the current revenues legally available to the Cities; and

WHEREAS, the Cities find that the performance of this Agreement is in the best interests of Cities' Departments, and that the undertaking will benefit the public; and

WHEREAS, the Cities desire to enter into a contractual relationship which makes the Consultant the health provider agency for the Services.

NOW THEREFORE, for good and valuable consideration, including the mutual covenants and conditions set forth herein, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

#### 1. Compensation.

**1.1.** The Cities and the Consultant agree to pay and bill, respectively, in accordance with the rates, fees and restrictions set forth in Sections 1.2, 4.1, 4.3, and 4.4 of this Agreement. The aggregate total not-to-exceed compensation amount for the Cities for the initial one-year term shall be One Hundred Thirty-seven Thousand Four Hundred Forty-nine Dollars and No Cents

**1.2.** The Consultant shall provide an invoice to the Cities for services rendered to their personnel during a calendar month by the 10th day of the next month. Each City will pay the undisputed charges in the invoice within thirty (30) days after receiving the invoice. Services will be itemized, and billed to each Party separately.

#### 2. Term.

- **2.1. Term.** The initial term of this Agreement shall be for one (1) year.
- 2.2. Options to Renew. The Cities are granted the option to renew the terms of this Agreement, individually or in any combination of two or more of the Cities. The Cities must notify the Consultant of intent to renew no later than sixty (60) calendar days prior to the termination date of the Agreement. The Cities shall have the option to extend this Agreement for four (4) one-year periods under the same initial terms herein, except the rates in Exhibit "A-1" will remain for years one (1) through three (3) and will be eligible for increase beginning in year four (4) at the lesser of the annual rate escalator of 5%, or the rate outlined in the National Health Expenditure Table for the most recent published year (Currently, Table 3 National Health Expenditures; Aggregate and per Capita Amounts, Percent Distribution and Annual Percent Change by Source of Funds: Calendar Years 2011-2027, as published by Centers for Medicare & Medicaid Services (CMS.gov)). The revised escalating rates will become effective on the first day of the each renewal contract period.
- **2.3. Notice of Desire to Renew.** Notice in writing of the desire to renew shall be provided to the Consultant. Such notice shall be sent by mail addressed to:

3. Cities' Obligations for Administration of Agreement. The shared Fire Chief of the Heartland Fire & Rescue (the "Heartland Chief", or such person designated by the Heartland Chief, shall administer this Agreement on behalf of the Cities, as it relates to fire personnel. The Chief of Police of El Cajon's Police Department (the "Police Chief"), or such person designated by the Police Chief, shall administer this Agreement on behalf of the El Cajon Police Department.

#### 4. Consultant Obligations.

- **4.1. Services.** The Consultant agrees to provide services rendered at the location identified in Section 4.2 below, to the Cities' employees receiving the Services (each, an "Employee"), at the cost and for the Services identified in Section 4.3. The Consultant agrees to perform and/or coordinate all Services identified in that certain proposal entitled "Proposal for The Cities of: El Cajon, La Mesa, Lemon Grove," dated October 3, 2023, attached hereto as Exhibit "A" and incorporated herein.
- **4.1.1. Personalized Written Health and Wellness Report.** Each Employee will receive an individual packet of the medical and fitness evaluation that outlines his or her results. The report will outline recommendations for each individual to improve and maintain fitness, as well as recommend treatment or follow up for any medical condition. Educational material regarding various health topics will be included in the packet.
- **4.1.2. Reporting and Recommendations.** The Consultant agrees to incorporate the current criteria used in Respiratory Fitness Clearance and Department of Motor Vehicles medical evaluations with regard to findings and risks. It is not the intention of the Consultant to re-define the existing fitness-for-duty criteria. Strict confidentiality and maintenance of records will be adhered to throughout any reporting and/or referral procedures.
- **4.1.3. Data Collection.** The Consultant will provide scientific and technical support related to data collection and analysis. Data shall be collected and stored on the electronic database designed by the Consultant specifically for the Services to be performed under this Agreement. Data Collection services shall include the following:
- **4.1.3.1.** Storage of past, current and future data on a secure server. Data shall be backed up weekly and kept at a remote location.
- **4.1.3.2.** Analysis of data for errors, omissions, and outliers. Statistical analysis shall be performed to summarize the demographic medical fitness outcomes on each Employee as well as a City's group as a whole or, in the case of El Cajon Employees, one report involving fire Employees to the Fire Chief and one report for the police Employees, to the Police Chief.
- **4.1.3.3.** Development of an annual report that shall be presented to senior staff of each City's Fire Department, and an annual report that shall be presented to El Cajon's Police Chief and senior staff.
  - **4.1.3.4.** Development of new strategies for data collection and reporting.
- **4.1.3.5.** Evaluating and analyzing data for individual and group disease management.

**4.1.3.6.** Integrating data with other fire departments in a confidential manner in compliance with all federal and state law.

#### 4.2. Facilities.

**4.2.1. Locations of Services.** The Consultant agrees to provide Services to Employees at the following locations:

El Cajon Fire Department & El Cajon Police Department 100 Civic Center Way El Cajon, CA 92020

La Mesa Fire Department 8054 Allison Avenue La Mesa, CA 91942

Lemon Grove Fire Department 7853 Central Avenue Lemon Grove, CA 91945

- **4.2.2. Staffing and Hours of Operation.** The Consultant shall commit to the days and hours of operation to comply with the goals of the Services.
- **4.2.3. Priority Appointments.** The Consultant shall maintain a licensed physician or PA available to examine and treat Employees who have appointments.
- **4.2.4. Medical Consultants.** The Consultant shall maintain a list of medical specialty consultants for referral to Employees.
- **4.2.5. Other Medical Services.** The Consultant shall provide radiological facilities to facilitate comprehensive examinations.
- **4.2.6. Weekend and Evenings.** The Services will not be available on weekends or evenings.
- **4.2.7. Canceled/Delayed Appointments.** The Cities are engaged in "All-Risk" emergency services, 24-hours a day. Due to unforeseen emergencies (fires, major incidents, disasters, etc.), it may be possible that an emergency crew and/or support personnel are otherwise engaged in emergency operations and unable to keep their appointments. All efforts will be made to provide personnel that are ready for their evaluations. The days of operation and the number of personnel to receive the Services will be determined based on an annual schedule and the need of the Cities, and will be in consultation with each City's Fire Chief, or designee, or El Cajon's Police Chief, or designee.

- **4.3. Pricing.** See Exhibit "A-1" attached hereto for pricing of the Services.
- **4.4. Pre-paid Fees for Services.** Services will be paid for after time of service, and within thirty (30) days of billing.
- **4.5. Prescriptions.** It is not the intention of this Agreement that the Consultant shall dispense medications during the scope of the Services. If the consulting physician identifies a need to prescribe a medication, he or she can provide a prescription at no additional cost, until the Employee can follow-up with his or her own physician, or make a referral to the Employee's own physician. The Cities shall not reimburse either the Employee or the Consultant for prescription or non-prescription medications.
- **4.6. Vision and Audiometric Examinations.** The Consultant agrees to provide vision and audiometric examinations to Employees as referenced by guidelines published by the California Department of Motor Vehicles.
- **4.7. Respiratory Examinations.** The Consultant agrees to provide respiratory examinations to Employees as referenced by guidelines published by the Occupational Safety and Health Administration.
- **4.8. Performance Standards.** It is the intent of the Consultant and the Cities to provide quality medical care and other wellness services for Employees. To maintain and improve the quality, access, availability, and cost-effectiveness of the services provided under this Agreement, the Consultant and the Cities each agree to use their best efforts to develop means and standards for measuring the performance of Employees under the Agreement, including, but not limited to the following:
- **4.8.1.** Measurement of key performance indicators, including workers' compensation savings, vital signs, cholesterol levels, and subjective surveys of Employees' satisfaction.
- **4.8.2.** Comparison of these indicators with other fire and police departments as available through the International Association of Fire Fighters (IAFF) Wellness Initiative database.
- **4.8.3.** Comparison of these indicators with other fire departments and police departments as available through regional data.
  - **4.8.4.** Other relevant factors to be established by the Consultant and the Cities.
- **4.9. Consultant Representative.** The Consultant hereby designates Greg Batla, CEO, to represent the Consultant in all matters pertaining to this Agreement.

#### 5. Administrative Services.

- **5.1. Periodic Meetings.** Subject to any state and federal privacy laws, the Consultant agrees to meet with the Cities' staff as scheduled to confidentially discuss program issues, utilization of medical specialties, utilization of physical therapy, trends and any topic of interest pertaining to the Services.
- 5.2. Work-Related Injuries: Initial Medical Reporting. While it is not the intent of the Consultant to diagnose or otherwise treat any suspected work-related injuries, in the course of a wellness/fitness evaluation a suspected work-related injury or illness may be discovered. The Consultant shall refer all Employees, with a suspected work-related injury or illness, to their employing City for coordination of medical care, unless a life-threatening medical emergency exists that requires medical treatment. The Consultant will direct the Employee to follow all proper procedures for reporting a work-related injury or illness. Following any emergency medical treatment, the Consultant shall report the treatment to the Employee's Department for the purposes of follow-up medical treatment. In the case of emergency medical treatment, the Consultant shall provide the Employee's Department with a Doctor's First Report of Work Injury or Illness (Form 5020) within two (2) days of initial treatment and all billing. The Consultant is not authorized to determine causation of any suspected work-related injury or illness.
- **5.3.** Work-Related Injuries: Medical Reports and Billings. The Consultant shall use those reports, billings and associated forms in a format approved by the Cities for any and all work related injuries reported.
- **5.4. Maintenance of Medical Reports.** The Consultant shall accurately maintain, store and retrieve Employee medical files during the period of this Agreement in accordance with all applicable laws and regulations.
- **5.5. Confidentiality.** The Consultant shall ensure security of the medical records for all Employees receiving Services and shall ensure compliance with all State and Federal Privacy Laws. At no time shall the Consultant release confidential medical records to the Cities without written authorization from the Employee.
- **5.6. Testimony.** The Consultant shall, upon reasonable notice, submit to depositions and testify at court if requested by the Cities provided that the Consultant and the affected City shall first agree upon an acceptable physician consulting rate.
- **5.7. Authorization for Patient Referral.** The Consultant shall insure that the Employee is instructed that any referral made to a specialist or hospital will *NOT* be reimbursed by the Cities unless authorized by both the Consultant and the Cities.

#### 6. Indemnification and Hold Harmless.

- 6.1. The Consultant agrees to defend, indemnify, protect and hold Cities and their elected and appointed officials, officers, agents, and employees harmless from and against any and all claims asserted or liability established for damages or injuries to any person or property, including injury to Employees, agents or officers, to the extent they arise from or are connected with or are caused or claimed to be caused by the negligence or willful misconduct of the Consultant and its employees in performing the work or services or supplying the materials or equipment under this Agreement, and all expenses, of investigating and defending against same; provided, however, that the Consultant's duty to defend, indemnify and hold harmless shall not include any claims or liability arising from the sole negligence or sole willful misconduct of the Cities and their elected and appointed officials, officers, agents, or employees. This shall not prejudice the rights of the Cities to appear in such suit, participate in the defense, and take such actions as may be necessary to protect the interests of the Cities. If the Cities choose, at their individual election, to obtain independent legal counsel in defense of any claim against them, related to the performance by the Consultant under this Agreement, then the Cities agree to pay the reasonable value of attorneys' fees and costs for such independent legal counsel; however, the Consultant shall not be obligated to pay attorneys' fees at an hourly rate greater than the hourly rate charged by its defense attorneys in the same matter. The Consultant's obligations under this Section shall be reduced dollar for dollar by any amounts the Cities are awarded in such action for attorneys' fees and costs.
- **6.2.** Each City agrees to defend, indemnify, protect and hold the Consultant and its agents, officers and employees harmless from and against any and all claims asserted or liability established for damages or injuries to any person or property, including injury to Consultant employees, agents or officers, to the extent they arise from or are connected with or are caused or claimed to be caused by the sole negligence or sole willful misconduct of the City providing such indemnification and its agents, officers or employees in performing the work or services or supplying the materials or equipment under this Agreement, and all expenses, of investigating and defending against same; provided, however, that the each City's' duty to defend, indemnify and hold harmless shall not include any claims or liability arising from the negligence or willful misconduct of the Consultant, its employees, agents and officers, or the other, non-involved, Cities. This shall not prejudice the right of the Consultant to appear in such suit, participate in the defense, and take such actions as may be necessary to protect the interests of the Consultant. If the Consultant chooses, at its own election, to obtain independent legal counsel in defense of any claim against the Consultant, related to the performance of the Cities under this Agreement, then the each City agrees to pay the reasonable value of attorneys' fees and costs for such independent legal counsel; however, the Cities shall not be obligated to pay attorneys' fees at an hourly rate greater than the hourly rate charged by their defense attorneys in the same matter. The Cities' obligations under this section shall be reduced dollar for dollar by any amounts the Consultant is awarded in such action for attorneys' fees and costs.

- **7. Termination.** This Agreement may be terminated for any reason by any party giving ninety (90) days written notice to the other party's designated representative, provided that the Indemnification and Duty to Defend provisions in Section 6 shall survive such termination, for a period of one (1) year.
- **8. Notice.** Notice to the Cities under this provision shall be communicated in writing, in person or by certified mail, return receipt requested, as follows:

**9. Equal Opportunity.** The Consultant shall comply with the Cities' Equal Opportunity Program.

- **10. Drug-Free Workplace.** Upon execution of this Agreement and all subsequent extensions, the Consultant agrees to comply with any requirements set forth in the Cities' policy regarding drug-free workplace.
- 11. Americans with Disabilities Act Statement. The Consultant shall be responsible for complying with the 1990 Americans with Disabilities Act ("ADA"). (For specific services and public accommodations under the ADA, the Consultant may contact the Office of the Americans with Disabilities Act, Civil Rights Division, U.S. District of Justice, P.O. Box 66118, Washington, D.C. 20035-6118; phone number (202) 514-0301.)
- **12. Integration.** This Agreement, and all rights and obligations created by this Agreement, shall be in full force and effect whether or not any Cities to the Agreement have been succeeded by another entity, and all rights and obligations created by this Agreement shall be vested and binding on any party's successor in interest.
- 13. Compliance with Controlling Law. The Consultant shall comply with all laws, ordinances, regulations, and policies of the federal, state, and local governments applicable to this Agreement. In addition, the Consultant shall comply within a reasonable time after receiving written notice by the Cities with all directives issued by the Cities or their authorized representatives under authority of any laws, statutes, ordinances, rules, or regulations. The laws of the State of California shall govern and control the terms and conditions of this Agreement.

#### 14. Reserved.

- 15. Jurisdiction and Venue. The venue for any suit or proceeding concerning the Agreement, the interpretation or application of any of its terms, or any related disputes shall be in the County of San Diego, Central Division, State of California. In the event of litigation in a U.S. District Court, venue shall lie exclusively in the Southern District of California, in San Diego. The Consultant hereby waives any right to remove any such action from San Diego County that is otherwise allowed by California Code of Civil Procedure section 394.
- 16. No Waiver. No failure of either the Consultant or the Cities or any City to insist upon the strict performance by the other of any covenant, term or condition of the Agreement, nor any failure to exercise any right or remedy consequent upon a breach of any covenant, term, or condition of the Agreement, shall constitute a waiver of any such breach or of such covenant, term or condition. No waiver of any breach shall affect or alter this Agreement, and each and every covenant, condition, and term hereof shall continue in full force and effect to any existing or subsequent breach.
- **17. Severability.** The unenforceability, invalidity, or illegality of any provision of this Agreement shall not render any other provision of this Agreement unenforceable, invalid, or illegal.

- 18. Drafting Ambiguities. The Cities and Consultant each agree that they are aware they have the right to be advised by counsel with respect to the negotiations, terms, and conditions of this Agreement, and the decision whether or not to seek advice of counsel with respect to this Agreement is a decision that is the sole responsibility of each party. This Agreement shall not be construed in favor of or against either party by reason of the extent to which each party participated in the drafting of this Agreement.
- 19. Changes. The Cities may order changes in the services within the general scope of this Agreement consisting of additions, deletions, or other revisions, and the contract sum and the contract time shall be adjusted accordingly. All such changes shall be authorized in writing, executed by the Consultant and the Cities.
- **20.** Assignment. The expertise and experience of the Consultant are material considerations for this Agreement. The Cities have an interest in the qualifications of and capability of the persons and entities that will fulfill the duties and obligations imposed upon the Consultant under this Agreement. In recognition of that interest, the Consultant shall not assign or transfer this Agreement or any portion of this Agreement or the performance of any of the Consultant's duties or obligations under this Agreement without the prior written consent of the City Council for each of the Cities. Any attempted assignment shall be ineffective, null and void, and shall constitute a material breach of this Agreement entitling the Cities to any and all remedies at law or in equity, including summary termination of this Agreement. The Cities acknowledge, however, that the Consultant, in the performance of its duties pursuant to this Agreement, may utilize subcontractors.

#### 21. Independent Contractor.

- 21.1 The Consultant is and shall at all times remain a wholly independent contractor and not an officer, employee or agent of the Cities. The Consultant shall have no authority to bind the Cities in any manner, or to incur any obligation, debt or liability of any kind on behalf of or against the Cities, whether by contract or otherwise, unless such authority is expressly conferred under this Agreement or is otherwise expressly conferred in writing by the Cities.
- 21.2 The personnel performing the services under this Agreement on behalf of the Consultant shall at all times be under the Consultant's exclusive direction and control. Neither the Cities, nor any elected or appointed boards, officers, officials, employees or agents of the Cities, shall have control over the conduct of the Consultant or any of the Consultant's officers, employees or agents, except as set forth in this Agreement. The Consultant shall not at any time or in any manner represent that the Consultant or any of the Consultant's officers, employees or agents are in any manner officials, officers, employees or agents of the Cities.
- **21.3** Neither the Consultant, nor any of the Consultant's officers, employees or agents, shall obtain any rights to retirement, health care or any other benefits, which may otherwise accrue, to the Cities' employees. The Consultant expressly waives any claim the Consultant may have to

any such rights, and shall indemnify and protect the Cities from and against any claims to such rights made by the Consultant's officers, employees or agents.

**22. Audit of Records.** At any time during normal business hours and as often as may be deemed necessary the Consultant shall make available to a representative of a City for examination all of its records with respect to all matters covered by this Agreement and will permit a City to audit, examine and/or reproduce such records. The Consultant will retain such financial and program service records for at least four (4) years after termination or final payment under this Agreement, whichever shall first occur.

#### 23. Insurance.

- **23.1** The Consultant agrees to obtain and maintain in full force and effect, during the term of this Agreement, commercial general liability insurance of not less than \$1,000,000. Such insurance policy shall comply with El Cajon City Council Policy D-3, which is attached hereto as Exhibit "B" and made a part of this Agreement. If there is any conflict between Exhibit "B" and this Section 19, the terms of Exhibit "B" shall apply. All insurance policies shall be subject to approval by the Cities as to form and content.
- 23.2 Consultant shall furnish properly executed endorsements and certificates of insurance to the Cities prior to commencement of services under this Agreement. Such endorsements and certificates shall:
- **23.2.1** Clearly evidence all coverages required above, including specific evidence of a separate endorsement naming the Cities as an additional named insureds;
- **23.2.2** Indicate whether coverage provided is on claims-made or occurrence basis; and
- **23.2.3** Provide that such insurance shall not be materially changed, terminated, or allowed to expire except on ten (10) days prior written notice, via first class mail to the Cities.
- **23.2.4** The Consultant agrees to provide the Cities with copies of all required policies upon request.
- 23.3 The Consultant shall also obtain and maintain professional liability insurance coverage in an amount not less than \$1,000,000.
- **23.4** The Consultant shall maintain Workers' Compensation insurance with statutory limits, and employer's liability insurance with limits of not less than \$1,000,000 per accident.
- **24. Authority to Execute.** The person or persons executing this Agreement on behalf of the Consultant represents and warrants that he/she/they has/have the authority to so execute this Agreement and to bind the Consultant to the performance of its obligations hereunder.

- **25. Signatures-Counterparts.** This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. This Agreement shall not be effective as to a party until the execution and delivery between each of the Cities of at least one set of counterparts. The Cities authorize each other to detach and combine original signature pages and consolidate them into a single identical original. Any one of such completely executed counterparts shall be sufficient proof of this Agreement.
- **26. Entire Agreement.** This Agreement, including the attached Exhibits "A," "A-1" and "B," is the entire, complete, final, and exclusive expression of the parties with respect to the matters addressed therein and supersedes all other agreements or understandings, whether oral or written, or entered into between the Consultant and any of the Cities prior to the execution of this Agreement. No statements, representations or other agreements, whether oral or written, made by any party, which are not embodied herein shall be valid and binding. To the extent that the terms and conditions of this Agreement conflict with, or are in any way inconsistent with, the terms and conditions of Exhibits "A," "A-1" and "B," the terms and conditions of this Agreement will prevail. No amendment to this Agreement shall be valid and binding unless in writing duly executed by the parties or their authorized representatives.

**SUBJECT:** Award of RFP No. 016-24 – Trash Capture Device Inspection, Cleaning &

Maintenance Services

#### **RECOMMENDATION:**

That the City Council:

- 1. Determines that the project is exempt pursuant to sections 15307 and 15308 of the California Environmental Quality Act (CEQA) state Guidelines; and
- 2. Adopts the next Resolution, in order, to enter into an agreement with Downstream Services, Inc., in an amount not to exceed \$177,000 for the initial one-year term, with up to four additional one-year renewal options.

#### **BACKGROUND:**

On August 3, 2023, the City of El Cajon issued a Request for Proposals (RFP) for Trash Capture Device (TCD) Inspection, Cleaning & Maintenance Services. The project will provide inspection, cleaning, and maintenance services on current TCDs and TCDs to be installed in the future and an opportunity for the City to renew the contract for up to four optional terms, each not to exceed one year in length.

Two proposals were received before 5:00 p.m. on October 4, 2023, and were independently reviewed by a three-person evaluation committee. The committee based its assessment on the evaluation criteria specified in the RFP: quality; project organization and key personnel; experience and references; data collection and tracking and reporting; and cost.

After thorough evaluation of the responses, the City determined the proposal received from Downstream Services, Inc. best met the City's requirements. If approved by City Council, the City Manager would have the authority to execute the agreement and subsequent renewals. The attached memorandum details the evaluation process.

#### CALIFORNIA ENVIRONMENTAL QUALITY ACT:

The proposed Trash Capture Device Inspection, Cleaning & Maintenance Services project is exempt from the California Environmental Quality Act (CEQA) in accordance with state CEQA Guidelines sections 15307 and 15308 as this action helps to assure the maintenance, restoration, enhancement, or protection of the environment.

#### FISCAL IMPACT:

The fiscal impact of the one-year term is \$177,000. Sufficient funds are available for this service in Fiscal Year 2023-24 Water Quality Improvements budget (193655PWCP). Subsequent 4-year costs are estimated to total \$1,630,000. Funds for the renewal terms will be in accordance with the approved budget for each fiscal year.

## RESOLUTION AWARDING REQUEST FOR PROPOSALS FOR TRASH CAPTURE DEVICE INSPECTION, CLEANING AND MAINTENANCE SERVICES (RFP No. 016-24)

WHEREAS, on August 3, 2023, the City of El Cajon (the "City") issued Request for Proposals No. 016-24 ("RFP No. 016-24") for Trash Capture Device ("TCD") Inspection, Cleaning and Maintenance Services (the "Project") for an initial one-year term, with the option to renew for four (4) additional one-year periods; and

WHEREAS, the Project will provide inspection, cleaning, and maintenance services on current TCDs, and TCDs to be installed in the future; and

WHEREAS, two (2) proposals were received by the deadline of 5:00 p.m. on October 4, 2023; and

WHEREAS, a three-person evaluation team independently reviewed the proposals according to the criteria specified in RFP No. 016-24, including quality; project organization and key personnel; experience and references; data collection and tracking and reporting; cost experience, references, turnaround, and cost factors; and

WHEREAS, after thorough evaluation of the responses, City staff has determined that the proposal received from Downstream Services, Inc. ("Downstream") best meets the City's requirements; and

WHEREAS, the fiscal impact of the initial one-year term of the Project is \$177,000.00, and sufficient funds are available in the Fiscal Year 2023-24 Water Quality Improvements budget; and

WHEREAS, subsequent 4-year costs are estimated to total \$1,630,000.00, and funds for the renewal periods will be in accordance with the approved budget for each fiscal year; and

WHEREAS, the Project is exempt from the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines sections 15307 and 15308 as this action helps to assure the maintenance, restoration, enhancement, or protection of the environment; and

WHEREAS, the City Council believes it to be in the best interest of the City to award RFP No. 016-24 to Downstream, and reject all other proposals, as recommended by staff.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL CAJON AS FOLLOWS:

- 1. The foregoing recitals are true and correct and are the findings of the City Council.
- 2. The City Council hereby determines that the Project is exempt under sections 15307 and 15308 of CEQA Guidelines.
- 3. The City Council hereby awards RFP No. 016-24 to Downstream Services, Inc. in an amount not to exceed \$177,000.00 for the initial one-year term, with up to four (4) additional one-year renewal options, and rejects all other proposals.
- 4. The City Manager, or designee, and City Clerk are authorized and directed to execute an agreement for the Project on behalf of the City of El Cajon (the "Agreement"), with such changes or amendments as maybe approved by the City Manager, or designee, and to take all actions and to execute all documents and/or attachments to the Agreement, and other documents necessary or appropriate to carry out the terms of the Agreement.
- 5. The City Manager, or designee, is further authorized to execute any amendments to the Agreement to extend the term for not more than four (4) additional one-year periods.

The City of El Cajon received two proposals for the above referenced Request for Proposal (RFP). The selection committee, comprised of personnel from Public Works' Engineering and Operations divisions, independently scored each proposal on the evaluation form included in RFP No. 016-24. The proposal evaluation form is based on a weighted scale with criteria including: 1) Overall Quality and Completeness, 2) Project Organization and Key Personnel, 3) Project Experience and References, 4) Exceptions, 5) Documentation, Data Collection, Tracking and Reporting, and 6) Cost, with a possible weighted average score of 100 points.

The weighted scores for Trash Capture Device: Inspection, Cleaning and & Maintenance Services (RFP No. 016-24) after evaluations resulted in the following ranking:

Vendor	Total Weighted
Downstream Services, Inc.	87.38
United Storm Water Inc.	77.92

#### Recommendation:

After reviewing proposals and cost proposals, the selection committee recommends that the City of El Cajon enter into a contract with Downstream Services, Inc. for Trash Capture Device: Inspection, Cleaning and & Maintenance Services. The proposed term of this contract is for one year with four one-year renewal options.

At the time RFP 016-24 was advertised, there were 121 existing Trash Capture Devices (TCDs). An additional 36 TCDs are installed this month for a total of 157 TCDS requiring inspection, cleaning and maintenance, starting in January 2024. The number of TCDs will increase over the next three years, in compliance with the State trash regulations. Initially, there will be 157 devices and an additional 150 will be installed in Year 2 (total of 307) and 50 more in Year 3, for a total of 357. Additional TCDs may be required in the future to be in compliance with the State Trash regulations.

Staff has calculated an approximate cost for the first five (5) years of the Inspection, Cleaning and Maintenance contract. These costs were determined based on the number of inspections and cleanings per unit/per year and an additional 20% was estimated/added for maintenance costs. The estimated cost for the contract for the first year (157 TCDs) is \$177,000.

Subsequent four year costs are estimated at: Year 2 (307 TCDs) - \$358,000; Year 3 (357 TCDs) - \$425,000 Years 4-5 (estimated 357 TCDs) - \$425,000/year. The total 4-year cost is estimated at \$1,633,000. The annual costs are likely to increase in subsequent years as additional TCDS are installed per the State Trash regulations.

#### RECOMMENDATION:

That the City Council:

- 1. Accepts an Emergency Access Easement at 1347 Shanessey Road; and
- 2. Authorizes the City Clerk to Record the Proposed Emergency Access Easement.

#### **BACKGROUND:**

The property owner of 1347 Shanessey Road is proposing to build a new single family residence (SFR) on the back side of the property, abutting the County of San Diego jurisdiction. The only way to access the back side of the property, however, is through an existing 12-foot driveway that cannot be further widened.

In accordance to California Fire Code requirements, the proposed SFR requires a minimum 16-foot wide driveway in order to accommodate a fire apparatus. Therefore, since the driveway cannot be further widened due to physical constraints on the property, the property owner is proposing to grant an emergency access easement to the City of El Cajon for appropriate access to the proposed SFR on the backside of the property; such easement will ensure all California Fire Code requirements are adhered to.

#### CALIFORNIA ENVIRONMENTAL QUALITY ACT:

This project is exempt from the California Environmental Quality Act (CEQA) pursuant to section 15303 of the state CEQA Guidelines because the emergency access will give emergency responders the ability to respond to the proposed dwelling unit and accessory structure.

#### FISCAL IMPACT:

There is no fiscal impact associated with this grant of emergency access easement.

#### EMERGENCY ACCESS EASEMENT AGREEMENT

This EMERGENCY ACCESS EASEMENT AGREEMENT ("Agreement") is entered into as of \_\_\_\_\_\_\_, 2023 (the "Effective Date") by and between Joseph S. Mazzenga and Angeline Y. Mazzenga, as Trustees of the Joseph and Angeline Mazzenga Family Trust 2015, ("Grantor"), and the City of El Cajon, a California Municipal Corporation and existing under the laws of the State of California, with offices located at 200 Civic Center Way El Cajon, CA 92020 ("Grantee" or the "City"). Grantor and Grantee are referred to herein as a "Party" and collectively as the "Parties".

#### RECITALS

- A. Grantor is the current owner of that certain real property located in the County of San Diego, State of California, as more particularly described in **Exhibit** "A" attached hereto and incorporated herein by this reference (the "Burdened Property").
- **B.** Grantee is the city of El Cajon, a California Municipal Corporation.
- C. Grantee has requested a permanent easement in, over, across and through those certain and limited portions of the Burdened Property and depicted on **Exhibit** "B" attached hereto and incorporated herein by this reference (the "Easement Area"), further defined in section 1 below, for the Easement Uses (as this term is defined in Section 1 below).
- **D.** Grantor is willing to grant such easement upon the terms and conditions set forth below.

**E.** Grantor or any subsequent owner of the Burdened Property is hereafter referred to as the "Burdened Owner".

**NOW, THEREFORE,** for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

#### **AGREEMENT**

- 1. Grant of Easement. Grantor hereby grants to Grantee an easement for Emergency Access described in the attached and incorporated Exhibit "B" for emergency use by the City, and/or emergency vehicles.
  - 1.1 Easement Area. The Easement Area shall begin on the south-end of the Burdened Property adjacent to Marrit Terrace and shall extend toward the Burdened property's driveway, at minimum 150 feet in length and 6 feet in width, as described in the attached and incorporated as "Exhibit B".
  - 1.2 Easement Use. This easement shall only be for stairs for the purposes of ingress and egress to provide, without limitations, fire and police protection, ambulances and rescue services and other lawful emergency government services to the premises, owners, occupants, and invitees thereof. The foregoing easement shall in no way be construed as a dedication of any property or roadways to the public.
- 2. Term. This Agreement shall continue in full force and effect from the date of recordation of this Agreement in perpetuity, unless this Agreement is amended, modified or terminated by an agreement executed, acknowledged and recorded by the Grantee and Grantor.
- 3. Obligations of Grantor. Grantor shall keep the Easement Area clear from any obstacles that will make the area un-accessible.
- 4. Binding Effect and Governing Law. This Agreement and all covenants and restrictions contained herein shall, to the fullest extent permitted by law and equity and without regard to technical classifications or designations, be deemed to be covenants running with the land of the Burdened Property and shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns. This Agreement is made with the intent of satisfying Section 1468 of the California Civil Code. This Agreement shall be governed and construed in accordance with the laws of the State of California.
- 5. Legal Proceedings. In the event of any controversy, claim, or dispute relating to the Easement Area or this Grant, the prevailing party shall be entitled to recover all reasonable costs and expenses thereof, including without limitation attorney fees and costs.
- **6.** Entire Agreement. This Agreement, including the recitals, Exhibit "A" and Exhibit "B", attached hereto, all of which are incorporated herein by this reference, constitutes the entire agreement between the parties with respect to the grant of easement hereunder.

- 7. Amendments. This Agreement may be amended, modified or supplemented only by a written document executed by all of the parties hereto (or their successors and assigns).



#### RECOMMENDATION:

That the City Council:

- 1. Determines that the project is exempt in accordance with section 15301(c) of the State CEQA Guidelines; and
- 2. Adopts the next Resolutions, in order, to:
  - a. Approve Plans and Specifications for Concrete Sidewalk Slicing, Bid No. 014-24;

  - b. Approve the application of the C-61/D-6 Limited Specialty/Concrete Related Services contractor's license and award the bid to the lowest responsive, responsible bidder, Trip Stop Sidewalk Repair, Inc., in the amount of \$490,000.

#### **BACKGROUND:**

The Concrete Sidewalk Slicing project encompasses concrete slicing with sidewalk uplifts from ½" -2" throughout El Cajon City limits and an opportunity for the City to renew the contract for up to four optional one-year terms. The bid was advertised on August 3, 2023, and the City received two bids on September 18, 2023; both responses were evaluated.

The bid specifications stated contractors shall have a current Class A – General Engineering or C-8 Concrete contractor's license issued by the Contractors State License Board of the State of California. Following the analysis of the bids, neither bidder possessed either of the above mentioned licenses but both did possess a C-61/D-6 – Limited Specialty/Concrete Related Services contractor's license. City staff concluded that the C-61/D-6 license is applicable to this service.

Staff recommends the City Council adopts resolutions to (1) approve the plans and specifications for the project, and (2) approve the C-61/D-6 – Limited Specialty/Concrete Related Services contractor's license and award the bid to the lowest responsive, responsible bidder, Trip Stop Sidewalk Repair, Inc., in the amount of \$490,000. The summary of bids is attached and complete proposals are on file in the Purchasing Division.

#### CALIFORNIA ENVIRONMENTAL QUALITY ACT:

The proposed Concrete Sidewalk Slicing project is categorically exempt pursuant to the California Environmental Quality Act (CEQA) state CEQA Guidelines section 15301(c), because the project involves the repair, replacement and maintenance of public sidewalks.

#### FISCAL IMPACT:

The fiscal impact for the initial one-year term is \$490,000. Sufficient funds are available for this service in Fiscal Year 2023-24 Annual Budget Gas Tax St Mnt-Repairs & Maint (211500). Subsequent 4-year costs are estimated to total \$2,049,977. Funds for the renewal terms will be in accordance with the approved budget for each fiscal year.



SUBJECT: Amendment to the 2023 Five-Year Program of Projects for the SANDAG

Regional Transportation Improvement Program (RTIP No. 23-08)

#### **RECOMMENDATION:**

That the City Council:

- 1. Opens the Public Hearing and receives testimony;
- 2. Closes the Public Hearing; and
- 3. Adopts the next Resolution, in order, approving the amendment to the proposed 2023 five-year program of projects for the SANDAG Regional Transportation Improvement Program (RTIP No. 23-08).

#### **BACKGROUND:**

Local SANDAG TransNet regulations require the City to hold a public hearing regarding any proposed amendments to the Five Year Regional Transportation Improvement Program (RTIP). TransNet is the countywide half-cent sales tax for local transportation projects that was first approved by voters in 1988, and extended in 2004 for another 40 years. The current five-year 2023 RTIP was formally adopted by City Council on May 10, 2022. The RTIP is a prioritized capital improvement program designed to implement the region's overall strategy for providing mobility and improving the efficiency and safety of the City's transportation system. The City receives approximately \$3.5 million annually in TransNet funds for transportation capital improvement projects.

This proposed amendment includes the following changes to the existing RTIP programmed list of projects and the TransNet account in the City's financial accounting system:

- Drawdown \$207,134.00 in available funds from the (EL03) Street Overlay account to close the Overlay 2020 (200020PWCP) project, providing for the re-paving of local and major streets within the City.
- 2. Reallocate \$12,149.00 (PW3687 and PW3720) of surplus funds from past fiscal year completed projects back into the (EL06) Traffic Signals account for current and new projects; and drawdown \$18,785.00 in available funds to close the traffic signal upgrades 2022 (223744PWCP) project, providing for the upgrade and modification of the City's traffic signal system to improve traffic flow and safety.

- 3. Reallocate \$17,648.00 (PW52020 and PW52021) of surplus funds from past fiscal year completed projects back into the (EL11) Sidewalk Improvement account for current and new projects, funding repairs to damaged sidewalks, and installing new sidewalks, curbs, and gutters at various locations throughout the City.
- 4. Drawdown \$56,212.00 in available funds from the (EL18) Street Light Improvements account to close the Street Light LED Retrofit (PW3658 and PW3718) projects; reallocating \$912.00 of surplus funds from the completed Repair and Replacement of Street Lights (PW3685) project back into the (EL18) Street Light Improvements account, providing for the upgrade and modification of the City's street light system to improve vehicle and pedestrian safety.
- 5. Drawdown \$237,656.00 in available funds from the (EL21) Street Resurfacing account to close the Slurry 2020 (PW51020) project, resurfacing and repairing (slurry seals) streets to prolong the life of existing pavement at various locations throughout the City.
- 6. Reallocate \$157,283.00 (PW3686) of surplus funds from past fiscal year completed projects back into the (EL29) Traffic Safety Calming account for current and new projects; and drawdown \$41,366.00 in available funds to close the Traffic Safety Calming 2021 (213719PWCP) project, providing for the installation of traffic safety calming devices to improve pedestrian and vehicle safety.

#### CALIFORNIA ENVIRONMENTAL QUALITY ACT:

The 2023 RTIP program of projects is categorically exempt from the provisions of the California Environmental Quality Act (CEQA), according to section 15301, Class 1(c) of the CEQA guidelines. Section 15301 contains an exemption for the maintenance of public roadways.

#### FISCAL IMPACT:

The proposed reallocation and drawdowns from the SANDAG TransNet funds to the aforementioned accounts does not impact any appropriations in the current Fiscal Year 23-24 budget, including the General Fund.

# RESOLUTION OF THE CITY EL CAJON ADOPTING/APPROVING AN AMENDMENT TO THE *TRANSNET*LOCAL STREET IMPROVEMENT PROGRAM OF PROJECTS FOR FISCAL YEARS 2023 THROUGH 2027

WHEREAS, on November 4, 2004, the voters of San Diego County approved the San Diego Transportation Improvement Program Ordinance and Expenditure Plan (*TransNet* Extension Ordinance); which has been amended from time to time in accordance with the applicable amendment requirements; and

WHEREAS, the *TransNet* Extension Ordinance provides that San Diego Association of Governments ("SANDAG"), acting as the Regional Transportation Commission, shall approve on a biennial basis a multi-year program of projects submitted by local jurisdictions identifying those transportation projects eligible to use transportation sales tax (*TransNet*) funds; and

WHEREAS, the City of El Cajon was provided with an estimate of annual *TransNet* local street improvement revenues for fiscal years 2023 through 2027; and

WHEREAS, the City of El Cajon approved its 2023 TransNet Local Street Improvement Program of Projects (POP) on May 10, 2022 and the City of El Cajon desires to make adjustments to its Program of Projects; and

WHEREAS, the City of El Cajon has held a noticed public hearing with an agenda item that clearly identified the proposed amendment prior to approval of the projects by its authorized legislative body in accordance with Section 5(A) of the *TransNet* Extension Ordinance and Rule 7 of SANDAG Board Policy No. 31; and

WHEREAS, City staff has recommended the proposed amendment to the RTIP, which does not impact any appropriations in the current Fiscal Year 23-24 budget including the General Funds, and includes the following changes to the scheduled list of projects:

- 1) Drawdown \$207,134.00 in available funds from the (EL03) Street Overlay account to close the Overlay 2020 (200020PWCP) project, providing for the re-paving of local and major streets within the City;
- 2) Reallocate \$12,149.00 (PW3687 and PW3720) of surplus funds from past fiscal year completed projects back into the (EL06) Traffic Signals account for current and new projects; and drawdown \$18,785.00 in available funds to close the traffic signal upgrades 2022 (223744PWCP) project, providing for the upgrade and modification of the City's traffic signal system to improve traffic flow and safety;
- Reallocate \$17,648.00 (PW52020 and PW52021) of surplus funds from past fiscal year completed projects back into the (EL11) Sidewalk

Improvement account for current and new projects, funding repairs to damaged sidewalks, installing new sidewalks, curbs, and gutters at various locations throughout the City;

- 4) Drawdown \$56,212.00 in available funds from the (EL18) Street Light Improvements account to close the Street Light LED Retrofit (PW3658 and PW3718) projects; reallocating \$912.00 of surplus funds from the completed Repair and Replacement of Street Lights (PW3685) project back into the (EL18) Street Light Improvements account, providing for the upgrade and modification of the City's street light system to improve vehicle and pedestrian safety;.
- 5) Drawdown \$237,656.00 in available funds from the (EL21) Street Resurfacing account to close the Slurry 2020 (PW51020) project, resurfacing and repairing (slurry seals) streets to prolong the life of existing pavement at various locations throughout the City; and
- Reallocate \$157,283.00 (PW3686) of surplus funds from past fiscal year completed projects back into the (EL29) Traffic Safety Calming account for current and new projects; and drawdown \$41,366.00 in available funds to close the Traffic Safety Calming 2021 (213719PWCP) project, providing for the installation of traffic safety calming devices to improve pedestrian and vehicle safety; and

WHEREAS, the 2023 RTIP program of projects is categorically exempt from the provisions of the California Environmental Quality Act ("CEQA"), according to section 15301, Class 1(c) of the CEQA guidelines, which contains an exemption for the maintenance of roadways.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL CAJON AS FOLLOWS:

- 1. That City of El Cajon requests that SANDAG make the changes in recitals (1) (6), above, to its 2023 POP (the "Amendment") as programmed in the 2023 RTIP.
- 2. Pursuant to Section 2(C)(1) of the TransNet Extension Ordinance, the City of El Cajon certifies that no more than 30 percent of its annual revenues shall be spent on local street and road maintenance-related projects as a result of the Amendment.
- 3. Pursuant to Section 4(E)(3) of the TransNet Extension Ordinance, the City of El Cajon certifies that all new or changed projects, or major reconstruction projects included in the Amendment and funded by TransNet revenues shall accommodate travel by pedestrians and bicyclists, and that any exception to this requirement permitted under the Ordinance and proposed was clearly noticed as part of the City of El Cajon's public hearing process for the Amendment.

BE IT FURTHER RESOLVED that the City of El Cajon does hereby certify that all other applicable provisions of the *TransNet* Extension Ordinance and SANDAG Board Policy No. 31 have been met.

BE IT FURTHER RESOLVED that the City of El Cajon continues to agree to indemnify, hold harmless, and defend SANDAG, the San Diego County Regional Transportation Commission, and all officers and employees thereof against all causes of action or claims related to City of El Cajon's *TransNet* funded projects.

**SUBJECT:** Sheltering Service for Pets of Homeless Individuals

#### RECOMMENDATION:

That the City Council receives the report and provides direction to staff.

#### **BACKGROUND:**

On September 26, 2023, Councilmembers Kendrick and Metschel introduced a proposal for the City Council to explore the feasibility of implementing a program that provides free sheltering for pets belonging to homeless individuals. In response to this proposal, the City Council directed staff to investigate an existing program operated by the San Diego Humane Society with the City of Carlsbad.

#### Summary of the Program

Staff acquired a copy of the agreement between the City of Carlsbad and the San Diego Humane Society (the Scope of Work is attached to this report). Key components of the agreement include:

- 1. Compensation: The agreement specifies a maximum annual compensation amount with a rate schedule that outlines daily boarding costs and expenses for procedures such as intake vaccines and microchipping. The maximum amount in the agreement is \$29,825, but Carlsbad is billed for actual costs only when a homeless individual shelters their pet with the Humane Society. The City covers the entire cost of boarding and any required medical care. Assuming all services are needed, a 14-day stay for a pet would cost \$393, with life-saving medical care capped at \$2,500 per animal.
- 2. **Duration of Stay**: The program permits up to 14 days of free sheltering.
- 3. **Referral Procedure**: Eligibility for the program is approved by Carlsbad's staff to ensure that only individuals homeless in Carlsbad or those seeking assistance can participate.
- 4. **Types of Animals**: The program accepts all legal pets, including dogs, cats, rabbits, birds, lizards, snakes, fish, and more.
- 5. **Participation Consent**: Pet owners are required to sign a "Waiver, Release, Hold Harmless, and Agreement not to Sue" and adhere to program rules.

- Visitation: Pet owners may visit their pets during specified hours. The Carlsbad agreement allows visits every day (except Mondays) from 10:00 AM to 4:00 PM.
- 7. **Exiting**: At the program's conclusion, the Humane Society is responsible for making good-faith efforts to contact the owner, with detailed procedures included in the agreement. If the animal is not retrieved, and the owner cannot be contacted, abandonment protocols are initiated.
- 8. **Reports**: The Humane Society provides a quarterly report to the City regarding program participation.

#### **Options to Consider**

Following a report of this analysis, the City Council may wish to direct staff to:

- 1. **Explore Alternative Sheltering Options**: Investigate other potential sheltering arrangements with alternative entities such as boarding facilities or animal volunteer groups.
- 2. **Negotiate with the Humane Society**: Initiate negotiations with the San Diego Humane Society to potentially establish a similar program in the City.
- 3. **No Further Action**: Choose not to proceed with the implementation of a pet sheltering program at this time.

#### CALIFORNIA ENVIRONMENTAL QUALITY ACT:

This is an informational item being considered by the City Council. Therefore, it is exempt from the California Environmental Quality Act (CEQA) because it is not a "project" under Section 15378(b)(5) of CEQA Guidelines. It is an organizational or administrative activity of government that will not result in a direct or indirect physical change in the environment.

**SUBJECT:** Fiscal Year 2023-24 First Quarter Report

#### RECOMMENDATION:

That the City Council:

- 1. Increases or modifies Fiscal Year 2023-24 appropriations in the amount of \$7,050,000 for additional needs as detailed in the report;
- 2. Authorizes the proposed personnel changes detailed in the report; and
- 3. Authorizes the proposed capital expenditures detailed in the report.

#### **BACKGROUND:**

#### Fiscal Year 2022-23 Results

Preliminary results indicate Fiscal Year 2022-23 ended with total General Fund revenues of \$95.0 million. This amount exceeded the final budget by approximately \$4.9 million. However, this is \$1.0 million less than projected during the assembly of the Fiscal Year 2023-24 Annual Budget. This strong performance was led by Sales Tax, which delivered \$1.3 million more than anticipated in the original budget. (These totals do not include the adjustment for Unrealized Gains/Losses; this adjustment may have a material impact once recorded.)

For the same period, General Fund expenditures totaled \$93.3 million. This was \$5.6 million below budget, although \$1.3 million above amounts projected for the Fiscal Year 2023-2024 Annual Budget. The primary driver of this variance is the Public Works department, which ended the year \$2.2 million under its \$10.3 million budget.

As a result of this combined activity, the General Fund closed Fiscal Year 2022-23 with an increase to reserves of approximately \$1.7 million.

#### First Quarter Budget Adjustments

Sewer Master Plan Update (650720)

Periodic assessment of the City's Sewer Master Plan is necessary to stay current with system requirements and changes in technology. Staff recommends increasing Wastewater Enterprise Fund (650720) appropriations, from fund equity, by \$300,000 to complete an update to this plan.

#### Oakdale Alameda Gateway Beautification (233785PWCP)

As the Oakdale Alameda Gateway Beautification project progresses, the Public Works Department determined it would be beneficial to increase the project budget by \$750,000, from the use of TransNet (EL03) funding, for the purpose of including new sidewalks and paving. Approval of this action will also increase TransNet appropriations by the same amount.

#### Overlay 2023 (233786PWCP)

This project was originally adopted as part of the Fiscal Year 2022-2023 Annual Budget to support the systematic enhancement of streets throughout the City. This proposed action expands the original project from \$1,930,000 to \$6,930,000 through the use of \$5,000,000 of TransNet (EL03) funding. Approval of this action will also increase TransNet appropriations by the same amount.

#### Slurry 2022 (233788PWCP)

This action proposes the use of \$1,000,000 of TransNet (EL21) funding to increase the total project budget to \$2,000,000. This project is a critical part of the maintenance plan of City streets. Approval of this action will also increase TransNet appropriations by the same amount.

#### Personnel Adjustments

On October 24, 2023, the City Council approved the reclassification of a Parks and Recreation Manager to a Deputy Director of Parks and Recreation. Approval of this action amends the positions authorized in the Fiscal Year 2023-2024 Annual Budget to reflect the reclassification. This change does not represent an addition to staff, it does affect the salaries and wages budget for the remainder of the fiscal year. However, no additional appropriation is required at this time.

A series of engineering positions has been established to acknowledge career growth and advancement between engineering classifications. This engineering series will allow employees to progress between the classifications of Project Assistant, Assistant Engineer, and Associate Engineer as minimum qualifications and educational requirements are met. This acknowledgment does not affect the number of positions authorized, and does not require a change in appropriations.

#### Capital Authorization

Included with this report are two requests for capital purchases. Additional information for each item is included in the attached Capital Outlay Requests. These requests are for authorization of capital expenses only and does not require additional appropriations.

- Executime Software from Tyler Technologies. This \$35,351 (estimated) purchase would allow electronic submission for time and attendance for all employees and provide advanced scheduling capabilities for City departments.
- Sports Field Netting for Wells Park Mini-Pitch. This expenditure was included in the FY22-2023 budget. However, due to availability issues, the order was not committed within the approved fiscal year.

#### CALIFORNIA ENVIRONMENTAL QUALITY ACT:

The proposed fiscal activities are exempt from the California Environmental Quality Act (CEQA) in accordance with sections 15301 (existing facilities), and 15378(b)(2) and (5). The capital expenditures maintain existing public facilities and government administration, and appropriations and personnel adjustments are government activities with no direct or indirect physical change to the environment.

#### FISCAL IMPACT:

This action will authorize \$7,050,000 of additional Fiscal Year 2023-24 expenditures. The attached summary of budget amendments details the individual impacts by funding source.

#### Description:

This is a primary entryway into the City due to its location immediately adjacent to the Second Street/Interstate 8 interchange. The project limits also include the conversion of an existing paved and unlit alleyway into a "green" alley that runs parallel to Second Street between Oakdale Avenue and Madison Avenue, and finally improvements along Walter Way which also runs parallel to Second Street between Madison Avenue and Main Street.

#### Justification:

The project will revitalize and beautify the existing City right-of-way by transforming them from inaccessible and deteriorating paved surfaces to vibrant, safe, and green spaces that foster accessible pedestrian connections – Alameda is where the community can enjoy culturally relevant art, shaded areas, and decorative safety and pedestrian scale lighting. The project is consistent with City Council Goals regarding beautification for entry ways to the City.

#### Scheduling:

Project will be completed by the end of 2024.

Funding is provided from a Clean California Grant and ARPA funds.
