## Determination of Sewer Connection Fee Using Plumbing Fixture Units

**General Guidelines:** Residential Developments, including single-family homes, condominium developments, apartments, second-family units (granny flats), trailer parks, churches, schools and laundromats should be evaluated for sewer connection fees using "Table 1: Family Unit Equivalents (Equivalent Dwelling Unit, or EDU) for Determination of Sewer Connection Fees."

All other residential, commercial, industrial and governmental developments should be evaluated for sewer connection fees using "Table 2: Plumbing Fixture Unit Values (PFUs) for Determination of Sewer Connection Fees." For the purposes of these calculations, one equivalent dwelling unit (1 EDU) shall equal twenty drainage fixture units (PFUs), or 265 gallons of sewage generated per day. Return to sewer calculations per day submitted by the manufacturer or engineer in writing may be used for determination of sewer connection fees for developments, such as car washes, where determination using plumbing fixture units (PFUs) is not defined.
