PUBLIC HEARINGS:

100 GENERAL PLAN CONSISTENCY REZONING PROGRAM
(Report: Anthony Shute, Deputy Director of Community Development)

RECOMMENDATION: That the City Council

- Open the Public Hearing and receive testimony;
- Close the Public Hearing;
- Move to ADOPT the next RESOLUTION in order ADOPTING the Negative Declaration; and
- Move to INTRODUCE the ORDINANCE for Zone Reclassification No. 2314.

DISCUSSION

Deputy Director of Community Development, Anthony Shute provided a summary of the Item.

Mayor Pro Tem McClellan objected to the maximum density proposed for certain sites.

City Manager Williford stated the zone reclassification is an implementation procedure to a previous City Council action. He stated that although this is fulfilling a State requirement, it gives the City an opportunity to upgrade aging or underutilized properties.

Councilmembers and **Staff** ensued in conversation regarding:

- Changing the demographics of the neighborhood;
- Density proposed;
- State requirements:
- Up-building the vacant, or under-developed properties;
- Higher quality development.

PUBLIC HEARINGS: (Item 100 – Continued)

Mayor Wells opened the Public Hearing.

Pat Wright expressed concern for what would be built in the vacant properties near the Third Street area. **Mayor Wells** clarified that nothing is being approved for building at this point, only a rezoning is being considered.

Councilmembers added that **Council** strives to make upgrades on any new construction being approved for the City.

Amir Oraha opposes the idea of up-building since it would bring more traffic to an already congested area.

Michael Semaan submitted a card but did not wish to speak. His card stated "it will bring us trouble and traffic".

Kelly Corn opposes the high density zoning change.

Mayor Wells explained that the City is meeting a State requirement by increasing the zoning density and explained the process.

Carlos Garcia expressed concern about the property values if more units are built and more traffic is brought into the neighborhood. He opposes the proposed rezoning.

Mayor Wells once again stated that these changes are to accommodate State requirements.

No further comments were offered.

MOTION BY WELLS, SECOND BY KENDRICK, to CLOSE the Public Hearing.

MOTION CARRIED BY UNANIMOUS VOTE OF THOSE PRESENT (AMBROSE – Absent).

Councilmembers spoke in support of newer construction and upgrades coming to El Cajon.

MOTION BY McCLELLAN, SECOND BY BALES, to INTRODUCE the Ordinance.

MOTION CARRIED BY UNANIMOUS VOTE OF THOSE PRESENT (AMBROSE – Absent).

City Clerk recited the title of the ordinance.

An Ordinance Rezoning Twenty-Five Properties To Be Consistent With General Plan Land Use Designations As Part Of The Implementation Of The 2013 Housing Element Including Rezoning The Properties Located At 110, 124, And 136 North Third Street And A Vacant Property On The Southwest Corner Of Melody Lane And North Third Street From The Rs-9 Zone To The Rs-6 Zone (General Plan Designation: Low Density Residential); Rezoning Property At 303 Hart Drive From Rs-9 To Prd-Low-Medium Zone (General Plan Designation: Low Medium Density Residential); Rezoning Properties At 330, 336, And 364 Wisconsin Avenue, 377 Chambers, 728 Ballantyne Street, 805 And 1123 North Mollison, 1160, 1178 And 1174 North Mollison Avenue, 920 And 924 South Magnolia Avenue, 395 North First Street, And 1419 Broadway From Various Zones To The Rm-2200 Zone; Rezoning The Properties At 824, 840, 850 Ballantyne Street, And A Vacant Property On The West Side Of Ballantyne Street And Assigned Apn 483-222-63 From The Rs-6 Zone To The Rm-2500 Zone (General Plan Designation: Low Medium Density Residential): And Rezoning Vacant Properties Located West Of 166 South Lincoln Avenue At The Southeast Intersection Of Two Unnamed Alleys South Of East Main Street, North Of East Lexington Avenue, East Of Taft Avenue, And West Of South Lincoln Avenue And Assigned Apris: 488-233-27 And 488-233-54 From P To Rm-1450 (General Plan Designation: High Density Residential).
